## A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that homelessness is a 2 societal problem that has plagued Hawaii and the nation for many 3 years. Although great strides have been made in addressing the 4 issue of homelessness, Hawaii has experienced an increase in the 5 number of homeless persons. Homelessness remains a complex 6 issue involving coordination, planning, implementation, and 7 funding among state and county agencies, nonprofit entities, and 8 the federal government.

On June 22, 2010, the cabinet secretaries from the federal 9 10 Departments of Housing and Urban Development, Labor, Health and 11 Human Services, and Veterans Affairs joined the United States 12 Interagency Council on Homelessness to unveil and submit to the 13 President and Congress the nation's first comprehensive 14 strategic plan to prevent and end homelessness. The United 15 States Interagency Council on Homelessness comprises nineteen 16 federal agencies to coordinate the nation's housing, health, 17 employment security, education, and human services functions and 18 to create a national partnership between every level of SB900 SD2 LRB 11-2220.doc

1 government and the private sector to maximize the effectiveness 2 of the federal government's response in addressing homelessness. 3 Described by the federal government as the most far-4 reaching and ambitious program in history to prevent and end 5 homelessness, the strategic plan will strengthen existing programs and forge new partnerships. With Congress, state and 6 7 local officials, faith-based and community organizations, and 8 business and philanthropic leaders across the country working 9 together, the plan will harness public and private resources to 10 build on proven local level innovations.

11 The legislature finds that Hawaii needs a mechanism similar 12 to the United States Interagency Council on Homelessness to 13 formulate and coordinate a unified plan to address homelessness 14 in all counties and facilitate the acquisition of federal 15 funding for homeless programs. The United States Interagency 16 Council on Homelessness recommends that the states establish such a state agency by legislative action or executive order, or 17 18 both.

19 The purpose of this Act is to establish the Hawaii 20 interagency council on homelessness and to make an appropriation 21 for its administrative expenses.

There is established the Hawaii interagency 1 SECTION 2. 2 council on homelessness, which shall be an advisory body exempt 3 from section 26-34, Hawaii Revised Statutes. The Hawaii 4 interagency council on homelessness shall be under the 5 department of human services for administrative purposes. The 6 director of human services shall serve as the ad hoc coordinator 7 of the Hawaii interagency council on homelessness. The members 8 of the Hawaii interagency council on homelessness shall serve 9 without compensation but shall be reimbursed for expenses, including travel expenses, necessary for the performance of 10 11 their duties. The Hawaii interagency council on homelessness shall be 12 13 responsible for organizing its member entities to formulate and 14 coordinate a unified plan to address homelessness in all counties and facilitate the acquisition of federal funding for 15 16 homeless programs. 17 SECTION 3. The Hawaii interagency council on homelessness shall be composed of at least one representative from each of 18 19 the following:

20 (1) The office of the governor, to be designated by the21 governor;

4	shall have the discretion to prioritize the duties, adapt or		
5	modify any duty to the circumstances, and refrain from		
6	exercising any duty if changing circumstances make the duty no

(5)	Partner with counties to identify resources and common
	strategies to end homelessness;
(6)	Seek to coordinate activities of statewide continuum
	of care collaboration entities;
(7)	Assemble accurate fiscal and demographic information,
	research, and data to support policy development and
	to track outcomes;
(8)	Establish priorities based upon the ten-year plan to
	end homelessness;
(9)	Recommend interagency strategies, including funding,
	homelessness prevention, and discharge planning;
(10)	Review all state activities and programs to assist
	homeless persons;

1 (11)Support and replicate collaborative state homelessness 2 initiatives of other states that demonstrate 3 measurable outcomes; 4 Promote systems integration of health services and (12)5 housing to reduce duplication among homeless 6 assistance programs; 7 Identify funding opportunities, including mainstream (13)8 resources for homeless persons; 9 Involve non-traditional stakeholders, including (14)10 representatives from corporations; business, 11 philanthropic, and faith-based organizations; and 12 other community institutions;

13 (15) Recommend to the legislature statutory changes and
14 recommend to the executive departments regulatory
15 changes to enhance the successful implementation of
16 this Act;

17 (16) Communicate problems and concerns relating to homeless 18 persons to the appropriate state or county agencies; 19 (17) Report annually to the governor, the legislature, each 20 county mayor, and each county council on the progress 21 of creating and implementing a ten-year plan to end 22 homelessness;

1 (18)Conduct a public education program on homelessness; 2 Disseminate information, including data and best (19) practices, to state and county officials and to the 3 4 public regarding issues related to homelessness; and 5 (20)Host or cause to be conducted an annual homelessness 6 conference. If any provision of this Act is found to be in 7 SECTION 5. 8 conflict with a federal requirement, the federal requirement 9 shall prevail and the provision shall be deemed to be amended to 10 conform to the federal requirement. 11 SECTION 6. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 12 or so 13 much thereof as may be necessary for fiscal year 2011-2012 and 14 the same sum or so much thereof as may be necessary for fiscal year 2012-2013 for administrative expenses of the Hawaii 15 16 interagency council on homelessness. The sums appropriated shall be expended by the department 17 18 of human services for the purposes of this Act. 19 SECTION 7. This Act shall take effect on July 1, 2050.
