## A BILL FOR AN ACT

RELATING TO THE HOMELESS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. To immediately implement the housing first
program under section 346-378, Hawaii Revised Statutes, the
department of human services shall:

4	(1)	Identify state, county, and privately-owned real
5		estate properties statewide that are appropriately
6		zoned and have necessary infrastructure in place for
7		the development of affordable rental housing for low
8		income individuals and families under the housing

10 Identify and provide a feasibility and cost analysis (2)11 regarding an appropriate site on state, county, or 12 privately-owned real estate property that is 13 appropriately zoned and has necessary infrastructure 14 in place for the development, by new construction or 15 refurbishing, of an initial housing-first program 16 model housing project that focuses on single resident 17 occupancy affordable rental housing; provided that the 18 site shall be centrally located within an urban core; 2011-0386 SB SMA.doc
