#### A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that the national and SECTION 1. 2 global economic crisis that began in the second half of 2008 has 3 caused significant economic problems in numerous industries in 4 the State, including the airline, cruise ship, tourist, and construction industries. Mass layoffs have been reported by an 5 increasing number of Hawaii businesses statewide, from the 6 agricultural sector to the medical-services sector. Difficult 7 economic times and declining tax revenues have resulted in 8 9 budget cuts for all state services.
- 10 The current and impending situation jeopardizes the safety
- net of basic human services, health, and education needs for 11
- Hawaii's residents and families. While all of Hawaii's 12
- 13 residents will be affected by the situation, gap group families
- and families closest to the poverty line will suffer the most. 14
- 15 Pursuant to Act 304, Session Laws of Hawaii 1999, the
- 16 legislature established the emergency and budget reserve fund as
- 17 a temporary supplemental source of funding for the State of
- Hawaii in times of emergency, economic downturn, or unforeseen 18



- 1 reduction in revenues. As set forth in section 328L-3, Hawaii
- 2 Revised Statutes, specific purposes for the fund include
- 3 maintaining levels of programs determined to be essential to
- 4 public health, safety, welfare, and education. Act 304 also
- 5 included certain prohibitions on appropriations from the
- 6 emergency and budget reserve fund. Appropriations for the
- 7 following purposes are specifically prohibited:
- 8 (1) To meet expenses of the legislature;
- 9 (2) To provide for salary adjustments for officials
- appointed pursuant to article V, section 6 or article
- 11 VI, section 3 of the Hawaii State Constitution and for
- others whose salaries are directly related to salaries
- of these officials; and
- 14 (3) To fund cost items in any collective bargaining
- 15 contract.
- The legislature finds that expenditures from the emergency
- 17 and budget reserve fund are needed to meet the conditions of
- 18 emergency, economic downturn, and unforeseen reduction in
- 19 revenues that the State currently faces. Further, the
- 20 legislature finds that the appropriations in this Act are
- 21 consistent with the purposes of the emergency and budget reserve
- **22** fund.



- 1 Therefore, given the current economic crisis and
- 2 concomitant budget deficit, the purpose of this Act is to
- 3 appropriate moneys from the emergency and budget reserve fund of
- 4 the State of Hawaii to maintain the levels of programs
- 5 determined to be essential to education, public health, and
- 6 public welfare.
- 7 SECTION 2. There is appropriated out of the emergency and
- 8 budget reserve fund of the State of Hawaii the sum of \$200,000
- 9 or so much thereof as may be necessary for fiscal year 2011-2012
- 10 for respite services.
- 11 The sum appropriated shall be expended by the department of
- 12 health for the purposes of this Act.
- 13 SECTION 3. There is appropriated out of the emergency and
- 14 budget reserve fund of the State of Hawaii the sum of \$1,500,000
- or so much thereof as may be necessary for fiscal year 2011-2012
- 16 to supplement the healthy start program.
- 17 The sum appropriated shall be expended by the department of
- 18 health for the purposes of this Act.
- 19 SECTION 4. There is appropriated out of the emergency and
- 20 budget reserve fund of the State of Hawaii the sum of \$950,000
- 21 or so much thereof as may be necessary for fiscal year 2011-2012

- to provide funding for grants pursuant to chapter 42F, Hawaii 1
- Revised Statutes, to be distributed as follows:

- 13 The sum appropriated shall be expended by the department of
- health for the purposes of this Act. 14
- 15 SECTION 6. There is appropriated out of the emergency and
- 16 budget reserve fund of the State of Hawaii the sum of \$100,000
- 17 or so much thereof as may be necessary for fiscal year 2011-2012
- 18 for the Aging and Disability Resource Center.
- 19 The sum appropriated shall be expended by the department of
- 20 health for the purposes of this Act.
- 21 SECTION 7. There is appropriated out of the emergency and
- 22 budget reserve fund of the State of Hawaii the sum of \$1,500,000



- 1 or so much thereof as may be necessary for fiscal year 2011-2012
- 2 for the developmental disabilities medicaid waiver program.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this Act.
- 5 SECTION 8. There is appropriated out of the emergency and
- 6 budget reserve fund of the State of Hawaii the sum of \$1,500,000
- 7 or so much thereof as may be necessary for fiscal year 2011-2012
- 8 for mental health services.
- 9 The sum appropriated shall be expended by the department of
- 10 health for the purposes of this Act.
- 11 SECTION 9. There is appropriated out of the emergency and
- 12 budget reserve fund of the State of Hawaii the sum of \$150,000
- or so much thereof as may be necessary for fiscal year 2011-2012
- 14 for the partnerships in community living program.
- 15 The sum appropriated shall be expended by the department of
- 16 health for the purposes of this Act.
- 17 SECTION 10. There is appropriated out of the emergency and
- 18 budget reserve fund of the State of Hawaii the sum of \$1,400,000
- 19 or so much thereof as may be necessary for fiscal year 2011-2012
- 20 for substance abuse treatment.
- The sum appropriated shall be expended by the department of
- 22 health for the purposes of this Act.



- 1 SECTION 11. There is appropriated out of the emergency and
- 2 budget reserve fund of the State of Hawaii the sum of \$125,000
- 3 or so much thereof as may be necessary for fiscal year 2011-2012
- 4 for the healthy aging partnerships program.
- 5 The sum appropriated shall be expended by the department of
- 6 health for the purposes of this Act.
- 7 SECTION 12. There is appropriated out of the emergency and
- 8 budget reserve fund of the State of Hawaii the sum of \$332,000
- 9 or so much thereof as may be necessary for fiscal year 2011-2012
- 10 to provide funding for grants pursuant to chapter 42F, Hawaii
- 11 Revised Statutes, to the Waianae District Comprehensive Health
- 12 and Hospital Board, Incorporated to support its emergency room
- 13 services.
- 14 The sum appropriated shall be expended by the department of
- 15 health for the purposes of this Act.
- 16 SECTION 13. There is appropriated out of the emergency and
- 17 budget reserve fund of the State of Hawaii the sum of \$270,000
- 18 or so much thereof as may be necessary for fiscal year 2011-2012
- 19 for HIV/AIDS related services.
- The sum appropriated shall be expended by the department of
- 21 health for the purposes of this Act.

- 1 SECTION 14. There is appropriated out of the emergency and
- 2 budget reserve fund of the State of Hawaii the sum of \$1,000,000
- 3 or so much thereof as may be necessary for fiscal year 2011-2012
- 4 to fund the housing first pilot program, through a collaboration
- 5 between the Hawaii public housing authority and the department
- 6 of human services, for chronically homeless individuals,
- 7 including those who have an addiction or mental illness, or
- 8 both.
- 9 The Hawaii public housing authority, in collaboration with
- 10 the department of human services shall prepare a report to the
- 11 legislature on the progress of the housing first pilot program.
- 12 They shall submit the report to the legislature no later than
- 13 twenty days prior to the convening of the regular session of
- **14** 2012.
- The sum appropriated shall be expended by the department of
- 16 human services for the purposes of this Act.
- 17 SECTION 15. There is appropriated out of the emergency and
- 18 budget reserve fund of the State of Hawaii the sum of \$500,000
- 19 or so much thereof as may be necessary for fiscal year 2011-2012
- 20 for meals for the elderly for kupuna care.
- The sum appropriated shall be expended by the department of
- 22 health's executive office on aging for the purposes of this Act.

- 7 or so much thereof as may be necessary for fiscal year 2011-2012
- 8 for the shelter plus care program.
- 9 The sum appropriated shall be expended by the department of
- 10 human services for the purposes of this Act.
- 11 SECTION 25. There is appropriated out of the emergency and
- 12 budget reserve fund of the State of Hawaii for QUEST health care
- 13 payments the sum of \$2,000,000 or so much thereof as may be
- 14 necessary for fiscal year 2011-2012 for the restoration of adult
- 15 dental care formerly granted under program ID HMS 245 QUEST
- 16 health care payments; provided that the funds shall not be
- 17 expended for any other purpose. The governor is authorized to
- 18 utilize enhanced federal medical assistance percentages funds to
- 19 offset the amount appropriated, provided that the total amount
- 20 shall not exceed \$2,000,000. Any unexpended funds shall lapse
- 21 to their respective funds.
- The department of human services shall prepare a report on:
