A BILL FOR AN ACT

RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that pursuant to Hawaii's 2 constitution, statutes, and case law, the State recognizes a mandate to protect native Hawaiian and Hawaiian traditional and 3 4 customary rights. 5 Certain state councils, boards, and commissions administer public trust resources and programs that directly impact native 6 7 Hawaiian and Hawaiian traditional and customary rights, natural resource protection and access rights, and the public trust. As 8 entities of the State, these councils, boards, and commissions 9 10 have a duty to protect and preserve these rights, and a 11 fiduciary duty to administer the public trust in the interest of 12 the beneficiaries, including native Hawaiians and Hawaiians. 13 The legislature finds that newly appointed members of these 14 state councils, boards, and commissions represent a broad range 15 of expertise and experience and therefore may not possess, upon 16 their appointment, knowledge of native Hawaiian and Hawaiian

rights and the public trust that would enable them to execute

their roles, fully informed of their responsibilities.

1	Chapter 10, Hawaii Revised Statutes, indicates that the		
2	office of Hawaiians affairs is the principal public agency		
3	responsible for ensuring that other state agencies protect		
4	native Hawaiian and Hawaiian rights. Section 10-1(b), Hawaii		
5	Revised Statutes, specifies that:		
6	"It shall be the duty and responsibility of all state		
7	departments and instrumentalities of state government		
8	providing services and programs which affect native		
9	Hawaiians and Hawaiians to actively work toward the goals		
10	of this chapter and to cooperate with and assist wherever		
11	possible the office of Hawaiian affairs."		
12	Section 10-3, Hawaii Revised Statutes, states that the		
13	purposes of the office of Hawaiian affairs include:		
14	"Serving as the principal public agency in this State		
15	responsible for the performance, development, and		
16	coordination of programs and activities relating to native		
17	Hawaiians and Hawaiians; except that the Hawaiian Homes		
18	Commission Act, 1920, as amended, shall be administered by		
19	the Hawaiian homes commission "; and		
20	"Assessing the policies and practices of other agencies		
21	impacting on native Hawaiians and Hawaiians, and conducting		
22	advocacy efforts for native Hawaiians and Hawaiians"		

- 1 Therefore, the legislature finds that to prepare these 2 state appointees to fulfill their roles and responsibilities, 3 fully informed of their duties and obligations, these state 4 appointees should be provided with training. The legislature further finds that the office of Hawaiian 5 6 affairs is the appropriate agency to train and educate the 7 members of appropriate councils, boards, and commissions about 8 native Hawaiian and Hawaiian traditional and customary rights, 9 natural resource protection and access rights, and the public 10 trust. 11 The purpose of this Act is to require members of appropriate state councils, boards, and commissions to undergo 12 13 training conducted by the office of Hawaiian affairs on native 14 Hawaiian and Hawaiian rights, the source of these rights, and how infringement of these rights impacts the native Hawaiian and 15 16 Hawaiian people. 17 SECTION 2. Chapter 10, Hawaii Revised Statutes, is amended 18 by adding a new part to be appropriately designated and to read 19 as follows: 20 "PART REQUIRED TRAINING RELATING TO NATIVE HAWAIIAN

AND HAWAIIAN TRADITIONAL AND CUSTOMARY RIGHTS,

3	§10-A Applicability of part. This part applies to members		
4	of the land use commission, the board of land and natural		
5	resources, the commission on water resource management, the		
6	environmental council, the board of directors of the		
7	agribusiness development corporation, the board of agriculture,		
8	the legacy land conservation commission, the natural area		
9	reserves system commission, the Hawaii historical places review		
10	board, and the board of health. This part does not apply to any		
11	other officer, representative, or employee of the State.		
12	§10-B Mandatory training relating to native Hawaiian and		
13	Hawaiian traditional and customary rights, natural resource		
14	protection and access rights, and the public trust, including		
15	the State's trust responsibility. (a) All council, board, and		
16	commission members enumerated in section 10-A shall complete a		
17	training course relating to native Hawaiian and Hawaiian rights		
18	administered by the office of Hawaiian affairs within six months		
19	of their official appointment date, as provided in this part.		
20	(b) The office of Hawaiian affairs shall establish,

4	council,	board, and commission members to whom this part
5	applies.	
6	(c)	The training course shall include, but not be limited
7	to:	
8	(1)	Historical information, explanations, and discussions
9		of key state laws, state constitutional provisions,
10		and court rulings that reaffirm and provide for the
11		protection of native Hawaiian and Hawaiian rights; and
12	(2)	A discussion of the importance of public trust
13		resources and various programs to native Hawaiian and
14		Hawaiian rights.
15	(d)	The office of Hawaiian affairs shall:
16	(1)	Develop the methods and prepare any materials
17		necessary to implement the training course;
18	(2)	Administer the training course; and
19	(3)	Notify each council, board, and commission member
20		enumerated in section 10-A that attendance in the

training course is required.

- 1 (e) The training course shall be conducted at least twice
- 2 in a calendar year.
- 3 (f) The office of Hawaiian affairs may repeat the training
- 4 course as necessary to accommodate all persons who are required
- 5 to attend.
- 6 (g) Each council, board, and commission chairperson shall
- 7 provide to the office of Hawaiian affairs, within thirty
- 8 calendar days upon their official appointment dates, the names
- 9 of those persons required to take the training course."
- 10 SECTION 3. In codifying the new sections added by section
- 11 2 of this Act, the revisor of statutes shall substitute
- 12 appropriate section numbers for the letters used in designating
- 13 the new sections in this Act.
- 14 SECTION 4. This Act shall take effect on July 1, 2012.
