A BILL FOR AN ACT

RELATING TO THE JUDICIARY COMPUTER SYSTEM SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 601-3.7, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) There is established in the state treasury a special
4	fund to be known as the judiciary computer system special
5	fund[-], that shall contain the following:
6	(1) Moneys collected from administrative fees pursuant to
7	section 287-3(a) [and fees];
8	(2) Fees prescribed by the supreme court by rule of court
9	for electronic document certification, electronic
10	copies of documents, and for providing bulk access to
11	electronic court records and compilations of data; and
12	(3) Fees pursuant to sections 607-4(b)(10) and 607-
13	5(c)(32) [shall be deposited into the fund]."
14	SECTION 2. Section 607-1, Hawaii Revised Statutes, is
15	amended to read as follows:
16	"§607-1 Power of supreme court with respect to costs and
17	fees. The supreme court shall have power by rule of court, from
18	time to time, to revise, amend, add to, or eliminate any of the

items of costs and fees provided in this chapter, to prescribe 1 such costs and fees as it deems reasonable in all cases not 2 therein provided for, and to prescribe the amount to be paid in 3 advance to the clerk of any court in any proceeding on account 4 of the costs and fees. All fees prescribed by the supreme court 5 6 by rule of court for electronic document certification, electronic copies of documents, and for providing bulk access to 7 electronic court records and compilations of data shall be 8 deposited into the judiciary computer system special fund." 9 10 SECTION 3. Section 607-2, Hawaii Revised Statutes, is 11 amended to read as follows: 12 "§607-2 Fees to be accounted for. With the exception of 13 [such fees as are] fees prescribed by the supreme court by rule 14 of court for electronic document certification, electronic 15 copies of documents, and for providing bulk access to electronic court records and compilations of data, that shall be deposited 16 into the judiciary computer system special fund, and fees 17 18 intended to reimburse officers for actual expenditures made by them, all judges', clerks', sheriffs', and deputy sheriffs' fees 19 provided for in this chapter and accruing from any action 20 pending in any court shall be deposited to the credit of the 21
