## A BILL FOR AN ACT

RELATING TO CERTAIN FUNDS OF THE UNIVERSITY OF HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 304A-2252, Hawaii Revised Statutes, is
 amended to read as follows:

3 "[{]§304A-2252[}] Child care programs [revolving] special 4 fund. There is established a child care programs [revolving] 5 special fund for the operation of child care programs 6 established under section 304A-116 and the construction and 7 renovation of child care centers established by the University 8 of Hawaii. Fees charged for child care at child care programs, 9 proceeds from donations to the university for child care 10 programs, and proceeds from loans or other instruments of indebtedness for the construction or renovation of child care 11 12 centers shall be deposited into the [revolving] special fund. 13 Expenditures from the [revolving] special fund shall be made for 14 the operation of child care programs and payment of principal 15 and interest on obligations incurred for the construction or 16 renovation of child care centers."



1 SECTION 2. Section 304A-2253, Hawaii Revised Statutes, is 2 amended as follows: 3 By amending subsection (a) to read: 1. 4 "(a) There is established a University of Hawaii research 5 and training revolving fund into which shall be deposited one 6 hundred per cent of the total amount of indirect overhead 7 revenues generated by the university from research and training programs. The board of regents is authorized to expend one 8 9 hundred per cent of the revenues deposited in the fund for: 10 Research and training purposes that may result in (1)11 additional research and training grants and contracts; 12 (2)Facilitating research and training at the university; 13 and 14 (3)Further deposit into the discoveries and inventions 15 revolving fund [and the University of Hawaii housing 16 assistance revolving fund]." 17 By amending subsection (c) to read: 2. Notwithstanding sections  $304A-107[\tau]$  and 18 "(C) 19 [[]304A-2254[], and [304A-2258]] to the contrary, the board of 20 regents or its designee, may establish a separate account within the research and training revolving fund for the purpose of 21 22 providing advance funding to meet reimbursable costs incurred in SB814 SD2 LRB 11-2379.doc 

1 connection with federally financed research and training 2 projects. Any reimbursement received as a result of providing 3 advance funding shall be deposited into the research and 4 training revolving fund to be used for the purpose of meeting 5 reimbursable costs incurred in connection with federally financed projects." 6 7 SECTION 3. Section 304A-2254, Hawaii Revised Statutes, is 8 amended to read as follows: 9 "[+]§304A-2254[+] Discoveries and inventions revolving 10 fund. There is established a discoveries and inventions 11 [revolving] special fund into which shall be deposited a portion 12 of the total indirect overhead funds generated by the university 13 for research and training purposes in the prior fiscal year, as 14 determined by the board of regents. Appropriations by the 15 legislature subject to the approval of the governor, proceeds 16 from the commercial exploitation of inventions and intellectual 17 property developed at the university, gifts, donations, fees 18 collected, and grants from public agencies and private persons 19 may also be deposited into the special fund for the purposes of 20 supporting innovation and research commercialization and the 21 patenting, copyrighting, licensing, and marketing of 22 discoveries, inventions, and technologies developed at the SB814 SD2 LRB 11-2379.doc

university. The <u>special</u> fund shall be used to develop
 technologies that have potential commercial value, support the
 administration of technology transfer activities, and facilitate
 economic development through education and research undertaken
 at the university."

6 SECTION 4. Section 304A-2259, Hawaii Revised Statutes, is
7 amended to read as follows:

8 "[{]§304A-2259[}] University of Hawaii alumni [revolving] 9 special fund. There is established the University of Hawaii 10 alumni [revolving] special fund into which shall be deposited 11 funds and proceeds received by the university from alumni 12 activities and donations from alumni. Funds deposited into this 13 [revolving] special fund may be expended by the university for 14 all costs associated with conducting alumni affairs, activities, 15 and programs for the university system, including but not 16 limited to expenses for honoraria, hotel and room rentals, food 17 and refreshment, printing and mailing, banners and signs, 18 plaques and awards, airfare and per diem, leis, rental of 19 audiovisual, musical, and stage equipment, and activity supplies 20 and materials, without regard to statutory competitive bidding 21 requirements."



1 SECTION 5. Section 304A-2261, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+]§304A-2261[+] University of Hawaii at Manoa 4 intercollegiate athletics [revolving] special fund and 5 University of Hawaii at Hilo intercollegiate athletics 6 [revolving] special fund. Notwithstanding any other law to the 7 contrary, there are established the University of Hawaii at 8 Manoa intercollegiate athletics [revolving] special fund and the 9 University of Hawaii at Hilo intercollegiate athletics 10 [revolving] special fund for the intercollegiate athletic 11 programs of the University of Hawaii at Manoa and the University 12 of Hawaii at Hilo, which shall be used to receive, deposit, 13 disburse, and account for funds from the activities of the 14 intercollegiate athletic programs. The university may establish 15 appropriate charges for activities related to its athletic 16 programs and the use of its athletic facilities, the proceeds 17 from which shall be deposited into these [revolving] special 18 funds.

19 The university shall maintain the financial integrity and 20 viability of these [revolving] special funds, including the 21 maintenance of an adequate reserve to cope with the various

3 SECTION 6. Section 304A-2262, Hawaii Revised Statutes, is

5 "[+]§304A-2262[]] Animal research farm, Waialee, Oahu 6 [**revolving**] **special fund.** There is established the animal 7 research farm, Waialee, Oahu [revolving] special fund for the 8 animal research farm, Waialee, Oahu, operated by the college of 9 tropical agriculture and human resources of the University of 10 Hawaii, into which shall be deposited the receipts from fees 11 realized from the sale of livestock, services, and supplies. 12 Funds deposited into this [revolving] special fund shall be 13 expended for animal research, and services and supplies related thereto." 14

15 SECTION 7. Section 304A-2264, Hawaii Revised Statutes, is 16 amended to read as follows:

17 "[+]\$304A-2264[+] Conference center revolving fund;
18 University of Hawaii at Manoa. There is established the
19 conference center revolving fund for the conference center
20 program in [the college of continuing-education and community
21 service of] the University of Hawaii at Manoa. All fees,
