SENATE CONCURRENT RESOLUTION

CONVENING A LEGISLATIVE NOISE POLLUTION TASK FORCE TO REVIEW BEST PRACTICES FROM OTHER STATES IN REDUCING URBAN NOISE POLLUTION.

WHEREAS, the traditional definition of noise is "unwanted or disturbing sound", which becomes unwanted when it either interferes with normal activities such as sleeping or conversation, or disrupts or diminishes one's quality of life; and

WHEREAS, the fact that noise cannot be seen, tasted, or smelled may help explain why it has not received as much attention as other types of pollution, such as air pollution, or water pollution; and

WHEREAS, noise pollution can have major consequences, primarily to a person's overall health; and

WHEREAS, studies have shown that there are direct links between noise and certain health problems, including stress-related illnesses, high blood pressure, speech interference, hearing loss, sleep disruption, and lost productivity; and

WHEREAS, noise-induced hearing loss is the most common and often discussed health effect, but research has shown that exposure to constant or high levels of noise can cause numerous adverse health effects; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-sixth Legislature of the State of Hawaii, Regular Session of 2011, the House of Representatives concurring, that the Director of Health is requested to convene a Legislative Noise Pollution Task Force to review best practices from other states in reducing noise pollution; and

BE IT FURTHER RESOLVED that the Task Force is requested to report its findings on best practices from other states in reducing noise pollution and its findings and recommendations to address excessive and disturbing noise levels to the Legislature no later than twenty days prior to the convening of the Regular Session of 2012; and
