Your Committee received testimony in support of this nominee from the Executive Officer of the Pest Control Board of the Department of Commerce and Consumer Affairs.

Upon review of the testimony, your Committee finds that this nominee for reappointment as a public member of the Pest Control Board has demonstrated a strong commitment to and understanding of his role as a member of this regulatory board. Your Committee notes that the nominee has attended twenty-one of the twenty-three meetings scheduled during his previous term of service with the Pest Control Board and has provided insights from the public's perspective that have been invaluable to the deliberations of the Board.
