Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 1070, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO CONDITIONAL RELEASE TIMEFRAMES,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this bill is to amend the law to establish a specific time limit for an order of post-acquittal conditional release when the defendant is charged with a petty misdemeanor, misdemeanor, or violation.
