"A BILL FOR AN ACT RELATING TO THE GENERAL EXCISE TAX,"

The purpose and intent of this measure is to amend Hawaii's tax laws that will allow the State to participate in the national Streamlined Sales and Use Tax Agreement.

Your Committee finds that this measure will make it possible for the State to collect interstate sales taxes without placing burdens on interstate commerce, thereby "leveling the playing field" between local and out-of-State retailers. Your Committee
