Your Committee on Housing, to which was referred H.B. No. 1586 entitled:

"A BILL FOR AN ACT RELATING TO OHANA HOUSING,"

begs leave to report as follows:

The purpose of this bill is to provide an Ohana Housing Tax Credit that would authorize a resident individual taxpayer to claim an income tax credit for a percentage of the total construction cost of any residential addition or expansion built solely to house eligible family members.

The Roman Catholic Church in the State of Hawaii and several concerned individuals testified in support of this bill. The Department of Taxation submitted comments.

Upon consideration, your Committee has amended this bill by:

- Eliminating the requirement that a claim for the Ohana Housing Tax Credit be applicable to residential additions or expansions built solely to house eligible family members;
- (2) Repealing the "eligible family members" definition;
- (3) Making a claim for the Ohana Housing Tax Credit contingent on the total construction cost of any residential addition or expansion built to house

individuals who reside in an emergency or transitional shelter, or who are on a waiting for such shelter or public housing; and

(4) Making technical, nonsubstantive amendments for clarity, consistency, and style.

No. 1586, as amended herein, and recommends that it pass Second Reading in the form attached hereto as H.B. No. 1586, H.D. 1, and be referred to the Committee on Finance.
