Your Committee on Transportation, to which was referred H.C.R. No. 43 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE LEGISLATURE TO SUPPORT THE EDUCATION OF HAWAII'S DRIVERS REGARDING THEIR RESPONSIBILITIES TO BLIND PEDESTRIANS,"

begs leave to report as follows:

The purpose of this concurrent resolution is to insure that Hawaii drivers are exposed to their responsibilities toward blind pedestrians during the driver licensing process.

Several concerned individuals who are also blind testified in support.

Act 75, Session Laws of Hawaii 1972, specifically established the responsibilities of Hawaii drivers toward blind pedestrians, yet none of Hawaii's counties have yet to include questions about these responsibilities on any driver licensing examinations. Most other states already include questions regarding blind pedestrians in their written driving tests.


A blind pedestrian has always faced challenges crossing our roads, particularly at intersections with right turn lanes. More recently they also face challenges with hybrid and electric vehicles because a blind person relies heavily on their hearing to guide them and is unable to hear an on-coming hybrid or electric vehicle. Thus your committee finds that it is reasonable to ask

the counties to include information regarding safety of the blind pedestrian in their driver licensing examinations.
