Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 1394, S.D. 1, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HAWAII PUBLIC HOUSING AUTHORITY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to allow the Hawaii Public Housing Authority to enter into contracts with eligible developers to develop public housing projects in exchange for commercial space in the project.

Your Committee on Conference finds that this measure will expand the Hawaii Public Housing Authority's ability to develop new housing for the State's lowest income populations by enabling the agency to incentivize partnerships with market-rate housing developers. Your Committee on Conference also finds that these incentives for partnerships will improve the financial
