"A BILL FOR AN ACT RELATING TO PROCUREMENT,"

The purpose of this bill is to preserve creativity and competition in the construction contract procurement process by establishing and incorporating the design-build method as an alternative procurement method into the Hawaii Public Procurement Code, to be employed at the discretion of the procurement officer.

Inouye Co., Ltd.; Bills Engineering, Inc.; MOSS Engineering, Inc.; Kai Hawaii; SSFM International; Pacific Geotechnical Engineers, Inc.; Consulting Structural Hawaii, Inc.; Kennedy/Jenks Consultants; InSynergy Engineering Inc.; The Limtiaco Consulting Group; American Council of Engineering Companies of Hawaii; General Contractors Association of Hawaii; and a company supported this bill. The State Procurement Office and Department of Transportation offered comments.

Your Committee has amended this bill by:

(1) Changing its effective date to July 1, 2030, to encourage further discussion; and
