Your Committee on Health, to which was referred S.C.R. No. 4
entitled:

"SENATE CONCURRENT RESOLUTION DECLARING THE MONTH OF MAY AS
LUPUS AWARENESS MONTH IN HAWAII,"

begs leave to report as follows:

The purpose and intent of this measure is to proclaim the
month of May of each year as "Lupus Awareness Month" in Hawaii to
raise awareness of the disease.

Your Committee received testimony in support of this measure
from Hawaii Medical Association, Lupus Hawai'i, Women in
Government, and one private citizen.

Your Committee finds that new research and new approaches to
diagnosis and treatment are needed to fight lupus, and that the
suffering of lupus victims can be alleviated through patient
services and the promotion of early detection of undiagnosed cases
through lupus awareness programs. Declaring one month out of each
year to lupus awareness will increase the public's knowledge of
the disease.

Your Committee has amended this measure by:

- (1) Amending its title; and
- (2) Making technical, nonsubstantive amendments for the
purposes of clarity and consistency.
