HB 1185

Status

MAKING AN APPROPRIATION FOR THE OPERATION AND MAINTENANCE OF THE EAST KAUAI IRRIGATION SYSTEM.

Appropriates funds for the continued operation and maintenance of the

east Kauai irrigation system.

HB 1524 Status

RELATING TO AGRICULTURAL THEFT.

Establishes, under the agricultural theft law, that possession of more

than five pounds of an agricultural product grown on the premises is prima facie evidence that the product has been stolen, unless a bill of

sale is provided.

HB 284 Status

RELATING TO AGRICULTURE.

Establishes an exclusion from the gross income, adjusted gross

income, and taxable income of a small farmer. Specifies that the exclusion is the lesser of (1) the amount earned from the sale of agricultural products produced on land of the small farmer or tours of

the agricultural operation on the land or (2) \$50,000.

HB 286 **Status**

RELATING TO AGRICULTURE.

Exempts the gross income or gross proceeds from the retail or

wholesale sale of a local agricultural product from the general excise

tax.

HB 288 Status

RELATING TO PLANTS.

Requires the board of agriculture to perform a risk assessment on

plants that pose a danger to, and are imported into the State.

HB 701

RELATING TO SCHOOLS.

AGR, EDN, FIN

Status

Requires the DOE to purchase agricultural products for school meals programs that have a farm within a school's regional administrative district. Requires the agriculture education program to arrange for opportunities for students to work, volunteer, or study on farms within

a school's regional administrative district.
