SB 1079, SD2 (SSCR642) Status	RELATING TO LANDOWNER LIABILITY.  Provides that owners of agricultural land or range land have no duty of care to trespassers. Establishes rebuttable presumption of no liability. Permits trespasser to overcome presumption by preponderance of evidence that owner was grossly negligent or intentionally injured the	AGR, JUD

trespasser. Authorized fines of up to \$10,000 for the offense of criminal trespass on agricultural lands. Effective 7/1/2050. (SD2)
