Testimony
Establishes notice and fact-finding requirements for the issuance of certificates of public convenience and necessity for water carriers;
expands the composition of the PUC to five members with a

representative from each county plus one at-large member; creates specialized subject-matter panels within the PUC; mandates the hiring of sufficient staff; creates the position of executive officer; requires electronic posting of information in connection with applications for certificates of public convenience and necessity; bars interim or temporary orders for certificates of public convenience and necessity

except in state-declared emergencies.

SB 781 RELATING TO PUBLIC UTILITIES. CPN, WAM

Creates a tax credit for electric utilities for undergrounding utility
