Authorizes schools to purchase fresh local produce under the school meals program and to grow food in school gardens for consumption in

the school lunch program.

HB 945 Status RELATING TO EDUCATION.

Requires multi track public schools to meet at least 171 days or 90 per cent of the minimum number of days required of other non-charter public schools for each respective school year, whichever number is greater, and at least 90 per cent of the minimum number of student instructional hours required of other non-charter public schools for each respective school year. Requires DOE to submit to the legislature a plan to implement a school year for multi track schools beginning with the 2015-2016 school year of no less than 90 per cent of the minimum number of instructional days and hours required of other

public schools.
