RELATING TO EDUCATION. EDU, WAM **SB 289** 

Appropriates funds for the Families for R.E.A.L. program and **Testimony** professional and curriculum development in parent involvement for the department of education and the early learning council; requires the Status program to develop a plan to cover an unspecified percentage of the program costs through fees, grants, and private donations, beginning

July 1, 2013; requires report to the legislature and governor.

**SB 871** RELATING TO EXTRACURRICULAR ACTIVITIES. EDU, WAM

Allows home schooled students to participate on an equal basis in **Testimony** extracurricular activities offered at the public school they would

otherwise be required to attend. **Status** 

RELATING TO EDUCATION. EDU, WAM **SB 1374** 

Allows home school students to participate in any extracurricular **Testimony** activities offered by a public school. Requires home school students to

pay applicable activity-participation fees. **Status** 

**SB 605** RELATING TO THE DEPARTMENT OF EDUCATION. EDU, WAM

Restructures the department of education into two major divisions – **Testimony** the academic achievement division and the administration division and establishes two senior deputy superintendent positions to head the **Status** 

divisions.

**SB 1485** RELATING TO RECONSTITUTING SCHOOLS. EDU, WAM

Allows the superintendent of education to reconstitute a public school, **Testimony** except for certain charter schools. Allows the superintendent to recommend actions to charter school review panel, including the **Status** 

revocation of a school's charter.

**SB 931** RELATING TO EARLY LEARNING. EDU, WAM

Appropriates funds to support operations of the early learning council.

RELATING TO EDUCATION. **SB 86** EDU, WAM

Requires children who are not attending a private school or **Testimony** kindergarten and who are at least 5 years of age on August 1 of the

school year to attend a public school kindergarten. Status

RELATING TO EDUCATION. **SB 1384** EDU, WAM

Makes attendance in kindergarten mandatory and lowers the **Testimony** compulsory education age from six to five years old. Requires children who are home-schooled or enrolled in alternative school **Status** programs for kindergarten to pass a standardized test approved by the

Board of Education prior to entering first grade in a public school.

RELATING TO EDUCATION. EDU, WAM **SB 1172** 

Exempts multi-track schools from required minimum of one hundred **Testimony** eighty instructional days; requires not fewer than one hundred

seventy-one days and one thousand eighty student instructional hours. Status

**SB 1375** RELATING TO EDUCATION. EDU, WAM

Requires multi track public schools to meet at least 171 days or 90 per **Testimony** cent of the minimum number of days required of other non-charter public schools for each respective school year, whichever number is **Status** 

greater, and at least 90 per cent of the minimum number of student instructional hours required of other non-charter public schools for each respective school year. Requires DOE to submit to the legislature a plan to implement a school year for multi track schools beginning with the 2015-2016 school year of no less than 90 per cent of the minimum number of instructional days and hours required of other

public schools.

RELATING TO EDUCATION. EDU, WAM **SB 190** 

Establishes a minimum instructional time requirement that is

**Testimony** applicable only to public multi-track schools.
