RELATING TO ENVIRONMENTAL PROTECTION.

Requires businesses to collect a 25 cent offset fee for distribution of every non-reusable checkout bag. Provides for the department of health to collect seventy-five per cent of offset fee to be used for administration and enforcement. Allows businesses to retain twentyfive per cent of offset fee as taxable income. Exempts offset fee from excise tax.
