(HSCR731) BONDS TO ASSIST PACIFIC POWER AND WATER COMPANY,

INC., IN THE DEVELOPMENT OF HYDROPOWER FACILITIES IN

HAWAII.

Authorizes the issuance of special purpose bonds in an unspecified amount to assist Pacific Power and Water Company, Inc. with the planning, permitting, designing, construction, equipping, and operating hydropower facilities throughout the State. Effective July 1, 2030. (HB855 HD1)

HB1286 HD2 RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE ENE, WAM (HSCR732) BONDS TO ASSIST BIOENERGY HAWAII, LLC.

<u>Testimony</u> Amends Act 110, Session Laws of Hawaii 2009, authorizing special purpose revenue bonds to assist BioEnergy Hawaii, LLC, by modifying

the purposes of the authorization. The authorization amount is

unspecified. Effective July 1, 2030. (HB1286 HD2)

<u>HB423 HD1</u> RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE ENE, WAM

(HSCR729) BONDS.

<u>Testimony</u> Authorizes issuance of special purpose revenue bonds for Carbon Bio-<u>Status</u> Engineers, Inc., for development of non-fossil fuel energy production.

HB122 HD1 RELATING TO RENEWABLE ENERGY. ENE/WLH, AGL

(HSCR638) Extends the repeal date of Act 173 (2009), which exempts renewable energy projects from subdivision requirements on State agricultural or conservation lands from July 1, 2013, to July 1, 2020. (HB122 HD1)

Establishes a pilot project within the department of land and natural resources to demonstrate the effectiveness of marine phytoremediation using plants that are native to Hawaii to remove pollutants and improve water clarity in Lake Wilson; appropriates funds for the project.
