### RELATING TO OUT-OF-STATE OFFICES.

ERB/INT, LMG,

FIN

Beginning 7/1/11, requires the auditor to conduct at least every two years a management and financial audit of the department of business,

economic development, and tourism out-of-state offices. Requires reports to the legislature. Repeals exemption from audit and

accounting requirements for out-of-state offices.
