Requires insurers, mutual benefit societies, and health maintenance organizations to pay health care providers directly regardless of the health care provider's participatory status with the insurer, mutual

benefit society, or health maintenance organization. Also requires nonparticipating providers who provide emergency services to be paid

promptly and directly for the treatment rendered.
