# RELATING TO SHIPBOARD GAMING.

<u>Testimony</u> Status Authorizes shipboard gaming on vessels in state waters. Establishes the Hawaii gaming board within DBEDT, an admission tax and a wagering tax, and a gaming fund for the deposit of fees, taxes, and

fines.
