SB 591, SD1 (SSCR357) Testimony Status	RELATING TO PHARMACY BENEFIT MANAGEMENT COMPANIES. Requires registration of and regulates practices of pharmacy benefit management companies. Requires periodic audits of pharmacies that submit claims to pharmacy benefit management companies. Effective 7/1/2050. (SD1)	HTH/CPN, JDL
SB 782, SD1 (SSCR85) Testimony Status	RELATING TO DANGEROUS WEAPONS. Prohibits any person from setting off, igniting, discharging, or otherwise causing to explode any homemade explosive device. Establishes a violation as a class C felony. (SD1)	PGM, JDL
