Removes time limit on requesting an absentee or permanent absentee ballot but not later than 4:30 p.m. on the seventh day prior to the election. Effective January 7, 2059. (HB1613 HD1)	JDL
HB 257, HD2 (HSCR920) Testimony Status	RELATING TO CAMPAIGN SPENDING. Provides regulation of automated phone calls, changes report filing deadlines, provides a cap of \$ on the price of fundraiser tickets that may be purchased with campaign funds, and applies notice and disclaimer requirements to an advertisement that is not paid for by an independent party. Effective January 7, 2059. (HB257 HD2)	JDL
HB 258, HD1 (HSCR78) Testimony Status	RELATING TO CAMPAIGN SPENDING. Changes report filing deadlines and requires filing of a supplemental report by candidate and noncandidate committees. Effective January 7, 2050. (HB258 HD1)	JDL
HB 716, HD1 (HSCR621) Testimony Status	RELATING TO ELECTIONS. Establishes new election deadlines to comply with state primary election date required by federal law. Effective January 7, 2050. (HB716 HD1)	JDL
HB 1368, HD2 (HSCR704) Testimony Status	RELATING TO ELECTIONS. Defines a party candidate and modifies the withdrawal process for a party candidate. Clarifies the filing process of nomination papers. Effective January 7, 2059. (HB1368 HD2)	JDL
