PBM, JUD (HSCR365) Recognizes the federally prescribed DD Form 93, or its successor form, as an acceptable method of determining the person authorized to Status direct disposition of an armed forces service member's remains. HB 1107 RELATING TO THE HAWAII NATIONAL GUARD. PBM, JUD Authorizes members of the Hawaii national guard to use non-lethal (HSCR364) weapons, including electric guns, when assisting civil authorities in Status disaster relief, civil defense, or law enforcement functions.
