(SSCR619) <u>Status</u>

Clarifies the circumstances under which a district court may serve a

RELATING TO UNIFORM REAL PROPERTY TRANSFER ON

DEATH.

Status

Adopts Uniform Real Property Transfer on Death Act; allows owner of real property to designate beneficiaries to receive real property upon death of owner without requirements of probate or formalities of wills.

Effective 7/1/2050. (SD2)

SB 946, SD1 (SSCR622) <u>Status</u>

RELATING TO THE JUDICIARY.

JUD, FIN

Establishes the access to justice trust fund under the judiciary as an endowment, to be administered by a nonprofit entity. Requires investment of the principal. Authorizes disbursement of interest earned to fund nonprofit legal service organizations to assist with the legal services needs of the poor, indigent, and other vulnerable

populations. Effective 7/1/2050. (SD1)

SB 1073, SD2 (SSCR703) Status

RELATING TO SURCHARGE FOR INDIGENT LEGAL

SERVICES.

Increases the amount of surcharges for indigent legal fees. Effective 7/1/2050. (SD2)

DECISION MAKING TO FOLLOW
