RELATING TO PROCUREMENT.

LAB/ERB, FIN

Requires the general contractor and applicable subcontractor for construction procurement under the Hawaii public procurement code to file certification of compliance with chapter 103B, HRS, with the notice of final completion of the contract. Provides that the general contractor shall not be sanctioned for noncompliance by a subcontractor. Allows general contractor to withdraw a bid prior to award of a contract if it finds it is unable to comply with eighty per

cent Hawaii workforce requirement. Effective 07/01/2050. (SD2)
