RELATING TO PUBLIC SAFETY. HB 491, HD1 PGM, WAM Requires the department of public safety to pursue and obtain (HSCR770) accreditation for the sheriff division from the Commission on Accreditation for Law Enforcement Agencies, Inc. Effective July 1, **Testimony** 2030. (HB491 HD1) **Status** HB 1252, HD1 RELATING TO GOVERNMENT FACILITIES. PGM, WAM Changes the formula for assessments on construction projects managed (HSCR659) by the department of accounting and general services to carry out the program of centralized engineering services. Effective on July 1, **Testimony** 2030. (HB1252 HD1) **Status** HB 453, HD1 RELATING TO PUBLIC ACCESS. PGM, JDL Clarifies that where public access is required as a condition of a (HSCR697) subdivision, either the county must accept dedication of and maintain **Testimony** the access or identify an entity to own and maintain the access. Authorizes county to require subdivider to provide establishment of a **Status** stewardship fund for maintenance purposes. Effective July 1, 2030. (HB453 HD1)

RELATING TO COVENANTS. HB 1431, HD1

Authorizes the counties to enact ordinances or adopt rules to enforce (HSCR847) covenants that run with the land that impose standards regarding use, maintenance, landscaping, and setbacks. Effective July 1, 2030. **Testimony**

RELATING TO FUEL TAXES. PGM, WAM HB 1626, HD1

PGM, JDL

Permits the County of Hawaii to appropriate the County's share of fuel (HSCR661) tax revenue for the maintenance of substandard private subdivision roads that are used by the public. Sunsets June 30, 2016. Effective **Testimony** 

July 1, 2030. (HB1626 HD1) **Status** 

HB 747, HD1 (HSCR684) Testimony	RELATING TO LIQUOR LIABILITY INSURANCE. Removes definition of convenience minimarts commonly referred to as a "mom and pop store". Effective January 7, 2059. (HB747 HD1)	PGM, CPN
Status  HB 587, HD2  (HSCR781)  Testimony  Status	RELATING TO COUNTIES. Authorizes each county's liquor commission to appoint and remove their respective liquor administrator, unless otherwise prescribed by their respective county charter. Effective July 1, 2030. (HB587 HD2)	PGM, JDL
HB 1339, HD1 (HSCR932) Testimony Status	RELATING TO LIQUOR COMMISSIONS. Requires county liquor commissions to adopt or amend rules by July 1, 2012, regarding conduct of patrons and to define the term "dancing." Effective January 1, 2059. (HB1339 HD1)	PGM, JDL
HB 551, HD2 (HSCR810) Testimony Status	RELATING TO ELECTRIC GUNS.  Permits county liquor authority investigators to possess electric guns.  Establishes safety measures that must be observed by county liquor authorities and internal reporting measures. Requires an annual report to the legislature. Effective January 7, 2059. (HB551 HD2)	PGM, JDL
