SB 98 Testimony Status	RELATING TO WATER CARRIERS. Requires public hearings before PUC approval of a water carrier's application for certificate of public convenience and necessity. Clarifies the required findings for a finding of public convenience and necessity. Clarifies notice requirements for public hearings.	TIA, CPN
SB 774 Testimony Status	RELATING TO TRANSPORTATION. Allow existing common carriers affected by an application for a certificate of public convenience and necessity to intervene in the matter; provided that at least ten per cent of the existing common carriers file to do so.	TIA, CPN
SB 1325 Testimony Status	RELATING TO MOTOR VEHICLE REGISTRATION. Defines "after market motorcycle frame" and allows the County director of finance to assign a vehicle identification number to a motorcycle with an aftermarket frame. Except for special interest vehicles, reconstructed vehicles and motorcycles with an after market frame, the bill disallows the registration of uncertified motor vehicles and devices.	TIA, CPN
SB 35 Testimony Status	RELATING TO THE MOTOR VEHICLE INDUSTRY LICENSING ACT. Amends section of motor vehicle industry licensing act to reflect updated statutory cross-references and make nonsubstantive technical	TIA, CPN [Measure added on 02-03-11]
