Status

Prior to the issuance of any grubbing, grading, excavation, or building permit for a development, all conditional county and state highway

improvements for the development shall be completed or under construction at the time of issuance of the permit.

HB 1610 Status RELATING TO MOTOR VEHICLE INSURANCE POLICY.

Prohibits stacking or aggregating uninsured or underinsured motorist coverage whenever there is more than one vehicle under the same

policy, with exceptions.
