Tuesday, March 15, 2011

The Senate of the Twenty-Sixth Legislature of the State of Hawai'i, Regular Session of 2011, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Solomon who was excused.

The President announced that he had read and approved the Journal of the Twenty-Ninth Day.

At this time, Senator Tokuda introduced robotics teams and their advisors from various high schools including Kalani High School with advisor Bryan Silver, McKinley High School with advisor Osa Tui, Castle High School with advisor John Yim, and Farrington High School with advisor Bebi Davis.

Senator Chun Oakland noted that March was National Social Work Month and welcomed students from Hawai'i Pacific University, Brigham Young University, and the University of Hawai'i at Mānoa who were brought to the Capitol by the National Association of Social Workers to participate in the Annual Social Work Legislative Day.

Senator Galuteria introduced very dear friends Carrie Ann Hewitt, former professor at the University of Hawai'i College of Education, and her husband Joe Fraser, former Vice Chancellor at the Batchelor Institute of Indigenous Tertiary Education, who have returned to Hawai'i to share their knowledge of indigenous and public education.
