TESTIMONY ON GOV. MSG. NO. 518 RELATING TO GUBERNATORIAL NOMINEE KALBERT K. YOUNG FOR DIRECTOR OF DEPARTMENT OF BUDGET AND FINANCE

Dear Chair Ige, Vice Chair Kidani, and members of the Committee:

Thank you for the opportunity to appear before you today in regards to my nomination to serve as the Director for the Department of Budget and Finance.

The Governor's offer to nominate me for the role of Director for the Department is not an opportunity that I considered lightly. The dire fiscal and financial condition of the State of Hawaii as a governmental entity is not really much of a secret to anyone. However, few people outside of this building can grasp the full depth and magnitude of that condition. Although it took only a day-and-a-half on the job for me to reach the sober reality that our State of Hawaii is in a far worst condition than even I had previously believed, it was not until after I agreed to the Governor's offer that I was able to truly visualize the depth of the challenges ahead of us. Even with that being said, I am ready to accept that challenge and look forward to working with the Governor, the departments and staff and, of course, the legislature.

I am originally from the University-area of Manoa on the island of Oahu, but have been working for the last 7 to 8 years on the island of Maui. I have worked in both the private and public sector. My most recent position was with the County of Maui as its Director of Finance – having served in that role for the last 6 years. During my tenure as Finance Director I helped make significant improvements in the County's overall financial position in both the operations of the department as well as for the larger strategic position of the County as a financial leader among its other governmental jurisdictions in the State of Hawaii. The County of Maui has significantly improved its financial stature as evidenced by some notable items below:

- Grown general fund carryover savings balances from approximately \$5 million (FY03) to more than \$60 million (FY10).
- Developed model and legislation for Post-Employment Obligations
 Fund which was initiated and established in Maui County, but from which, was adopted by other counties and cities in the State.
- Established funding strategy to address County's annual required contribution to address its unfunded liability for non-pension retirement benefits (OPEB).
- Real property tax policy that reduced real property tax rates from FY04 to FY09.
- Removed negative watch rating on County credit in 2005.
- Secured credit rating upgrades from all three major rating agencies in 2007 and by Standard & Poor's in 2010.
- Structured bond transactions to refund debt and to take advantage of Federal ARRA financing programs. The County's November 2010 \$73M G.O. bond transaction had a net true-interest-cost of less than 2.50%.

Please keep in mind that many of these accomplishments were achieved during a period of the economic down-cycle.

My background also includes work experience in the private sector for the Kamehameha Schools Bishop Estate where I worked in the area of government affairs, budget & financial planning, and internal audit. During my time at KSBE, the institution also undertook significant structural re-organization and expansion. I was fortunate to be involved with the organization during that historical period

and equally grateful to have been involved enough to work with the staff and management there during its evolution. This combination of work experience and background over the last 15 years includes a large breadth of organizational budgeting and financial management of importance to sustaining revenue, debt financing, and capital projects.

My vision for the Department of Budget and Finance is to build on, and build up, its credibility. In these difficult financial times, the department and I expect to stand as the organizational guide towards improving the overall financial condition. However, I do not want the Department of Budget and Finance to be, in perception or form, the road block to executing departmental operations. B&F will assist other departments and agencies in the accountable execution of their appropriated budgets.

To follow are some of the short-, intermediate-, and long-term issues that I consider as goals and/or upcoming issues to address.

In the short term, the number one goal has been to construct the FY12/13 budget. The vast majority of energy and attention of the staff, the deputy and me have been towards this effort. Beyond the budget construction efforts, the deputy and I have already begun work on several policy areas of importance. The goal is to make processes contemporaneous and consistent with some of the best practices for organizations of similar size and responsibilities in the private sector, but also to install procedures and policies that are modern and consistent with other governmental jurisdictions.

Short term (0-8 months)

- Advise Governor and direct departments on the construction of the FY12/13 budget.
- Construct FY12/13 budget within parameters established by Governor and submit to legislature.
- Review executive branch policies related to the execution and administration of the budget
- Review departmental policies, practices, and procedures related to the Treasury function.

> Amend, revise and update policies in Treasury function in the area of the short-term investment policy, underwriting selection criteria, and debt management policy.

Intermediate Term (6-18 months)

- Implement processes, policies, and guidelines aimed installing more fiscal accountability to departments to manage their annual budgets.
- Explore contemporary financing opportunities for large-scale capital projects.
- Begin framework and construction for second-year biennium budget construction.
- Improve IT functionality and capabilities within department.

Longer Term (12-36 months)

- Develop strategy for deliberation with Executive and Legislative branch to address unfunded liability issue for pension and OPEB.
- Improve financing capabilities and/or options for agencies and departments to fund development, capital projects, or private/public project initiatives.
- Secure improved IT functionality within the department to assist with budget construction and financial reporting.

Overall Goal

- Improve State credit rating.
- Increase debt financing capabilities at the State either through new funding mechanisms or reduced debt load.
- Implement pro-active strategy that addresses unfunded liability.

In closing, I believe that my background and experience are valuable assets in a nominee for the position of Director for the Department of Budget and Finance. I respectfully request your favorable consideration and am open to discuss any aspect of my professional background that you may have.
