I am writing in support of GM 521 nominating Judge Sabrina McKenna to the position of Associate Justice of the Hawaii Supreme Court for a term of ten years.

Judge McKenna received her bachelor degree from the University of Hawaii at Manoa and her law degree from the William S. Richardson School of Law in 1982. While at Richardson School of Law, Judge McKenna served as the Editor-in-Chief of the University of Hawaii Law Review. Following graduation Judge McKenna practiced law as an associate at the Goodsill law firm and as general counsel to Otaka, Inc. She also worked as an associate professor at Richardson School of Law. Judge McKenna served for two years on the State District Court before becoming a Circuit court judge in 1995. Currently she serves as the senior judge of Oahu's Family Court and was primarily responsible for the Family Court's move to the new facilities at the Kapolei court complex.

In addition to her impressive work accomplishments, Judge McKenna has been the recipient of numerous awards including the Richardson Law School Outstanding Alumnus Award, University of Hawaii Distinguished Alumnus Award, the Hawaii Woman Lawyers Outstanding Judicial Achievement Award, the Dr. Martin Luther King Friends Award from the Hawaii Friends of Civil Rights and the Certification of Distinguished Service by the Hawaii Joint Police Association.

As an attorney I have had the opportunity to practice before Judge McKenna. I have found her to be knowledgeable of the law and able to understand and apply the facts before her fairly and compassionately. I do want to emphasize that this is a letter of support that I have been hoping to pen one day. The reason is that Judge McKenna is someone who stands on her own merits. It should not matter what her gender, ethnicity, religious belief or sexual orientation is or represents. What matters is that she is a person who is very qualified to hold this position.

I would like to know the Judge's position on the Federal Question concerning the Right to Privacy and Choice in Medical Care.

I would like to know the Judge's position on the Right to Life, not on the Abortion question, but on living persons.

Specifically, for Hawaii State Citizens do they have both the Right to Life and Choice in Medical Care?

Also, since the State of Hawaii under Article IX is empowered to "protect and promote the public health", can the State of Hawaii restrict health care delivery or have any power concerning individual [not public health] health care?

I would support the Judge if her answers:

- 1. 100% support the Right to Life and Privacy, Choice in Medical Care; and,
- 2. If her answer is Yes to Hawaii State Citizens having both the Right to Life and Choice in Medical Care; and,
- 3. if her answer is NO, the State of Hawaii can NOT restrict health care delivery; and,
- 4. NO, The State of Hawaii does NOT have any power concerning individual [not public health] health care.

Otherwise, I don't think that she will be confirmed.

Health Care is a Fundamental Human Right protected in the Constitution right up there with Freedom of Religion and Life, Liberty and the pursuit of happiness. In the unanimous opinion of the US Supreme Court this right, although not listed in the letters of the Constitution, is 100% by the Constitution remaining SILENT, the Right of Privacy.

Any inkling of an adverse opinion is a automatic Constitutional Disqualification and a violation of the Vow to Support and Defend the Constitution of the United States of America and the State of Hawaii.

Good morning, Senator Hee and members of the Committee:

My name is Tom Farrell. I am an attorney and the chair of the Family Law Section of the Hawaii State Bar Association, on whose behalf I testify this morning.

The Family Law Section is comprised of over a hundred attorneys who practice primarily in Family Court. We handle divorce, paternity, domestic violence, child protection and guardianship cases. As a Section, our testimony represents the views of our members only; we do not speak on behalf of the entire Hawaii State Bar Association.

We strongly support this nomination and urge the entire Senate to confirm Judge McKenna as an Associate Justice of the Supreme Court of Hawaii.

Frankly, we would be very happy to keep Judge McKenna right where she is: as the Senior Family Court Judge in the First Circuit. However, based upon what we have seen in the year that she has served in this extremely challenging position, we cannot help but admit that the people of Hawaii would be well served by Judge McKenna's appointment to a position of increased responsibility.

As the leader of a court of eleven judges handling literally tens of thousands of difficult and emotional cases every year, Judge McKenna has performed superbly. She was responsible for Family Court's move from the downtown courthouse to the new Kapolei Judiciary Complex. This could have been a logistical and administrative nightmare, but with her careful planning and execution, it was a seamless transition. Judge McKenna has demonstrated genuine concern for the wellbeing and working conditions of the hundreds of Family Court clerks, bailiffs, and other support staff. She keeps the Family Court Bar informed of what is going on in the courts; she invites our members to sit on committees and working groups; and she has always responded promptly whenever our Section has brought an issue or concern to her.

In the exercise of her adjudicative functions, Judge McKenna has an excellent reputation among our members. I have personally appeared before her many times. She is prepared, she knows the law, and she can apply the facts and law in a decisive and common-sense manner. She is inquisitive---perhaps a bit more inquisitive than one of my clients may have liked---but she is truly concerned about doing justice. The manner in which she approaches the cases on her dockets makes all of us who practice in her court bring up our game, and that is a very good thing for us and for the clientele that we serve.



My name is Patricia Kline. Judge McKenna's wise ruling in our case kept our family together.

On September 18, 2010, my sister, Sydney Kline, was brutally murdered in the street in front of her home in Kaneohe. Our family was devastated. As sisters, we were incredibly close. My sister's only child, Kiera, age 12, was orphaned. Kiera's father had abandoned his family before Kiera's birth. All of Kiera's life, I had served as a second-mother, with Kiera spending many summers and vacations with my husband and I in our home in California. We immediately stepped up to seek custody of Kiera, and to bring her back with us to our home in California. At that time, I was seven months pregnant, with a son who we had already intended to name Sidney before my sister's untimely death. Sydney's passing and now suddenly seeking to add Kiera to our growing family, made baby Sidney's imminent arrival a blessing amidst our inconsolable grief.

The only other incident that could of hurt us as bad as losing my sister Sydney, was to lose Kiera as well.

That almost happened when Kiera's estranged biological father, whom Kiera had never met, came forward to seek custody of Kiera. It was Kiera's father intention to remove Kiera from us, force her to live with a man she had never met, be raised by his now-wife whom she had never met, and relocate Kiera to his home in North Carolina, where she had never been.

The case this stranger of a man brought against our family during our time of incredible loss and sadness should be inconceivable, but it was not. We were faced with fighting the legal fight of our lives: the fight to protect and save Kiera.

Judge McKenna had our time sensitive case expedited, due to my problematic pregnancy I was enduring. Kiera was also experiencing incredible anxiety, not knowing what was to become of her and what family she would be with. It was clear that Judge McKenna was primarily concerned with the well-being of Kiera.

Judge McKenna tried to help our family by offering our grieving family mediation with Kiera's father. No agreements were reached, and the case went to full trial. Judge McKenna's thoughtful considerations to our unique situation, and insightful questions during trial reflected her vast legal expertise. Kiera's future rested in the hands of Judge McKenna.

With Baby Sidney's healthy arrival, and Kiera now home safe with us, we move forward, every day, as a family.

My daughter Sydney L. Kline was murdered on September 18, 2010 by her fiancé. I was with Sydney when she was murdered, witnessed her death and was also attacked. Sydney had one child, Kiera Kiani Kline, who is twelve years old. When he was informed of Sydney's death, Kiera's biological father, who had never once met her in her entire life, wanted to obtain full custody of Kiera.

Needless to say, I was shocked and devastated with the thought of losing another child. Kiera and I have always been close and the thought of her going with her biological father (a virtual stranger) was beyond belief and common decency.

Our family was fortunate to have Judge McKenna assigned to our case. We began our court proceedings in October and had to appear numerous times for trial in Kapolei. She was compassionate, fair and understanding in terms of all the complicities involved in our case. She has helped our family begin to heal and believe that there is justice and fairness in the world, a world which was so absolutely turned upside down and inside out.

I believe wholeheartedly that Judge McKenna would an asset to Hawaii's Supreme Court. She is someone who has vast experience, compassion, wisdom and Aloha. She has and will serve Hawaii well in this capacity.

I prepare this written testimony with the hope that I can also submit my oral testimony in support of the nomination of Judge Sabrina McKenna to the Supreme Court of the State of Hawaii as Associate Justice.

I am a trial lawyer who has known Judge McKenna since her appointment to the Circuit Court. Since that time, I have had numerous contacts with her. My contacts with her have included arguing motions, participating in settlement conferences and trial of cases. In view of the fact that I am an extremely active trial attorney with many trials under my belt in 41 years of practice in the state of Hawaii, I believe that I am in an excellent position to evaluate Judge McKenna for the position for which she has been nominated.

I do not know of a judge who brings to the bench a greater sense of compassion, integrity, intelligence, judicial temperament, self-deprecation and command as does Judge McKenna. I feel that Sabrina McKenna is apart of a Legal Conspiracy scheme to eliminate and minimize payout compensation for individuals hurt in Personal Injury Cases. She should be investigated for possible illegal connections with the insurance industry for receiving special benefits. The way that she handled my personal injury case, clearly shows that she may be connected with insurance fraud and appears to have made is so difficult for me to obtain compensation for my injuries. I do have lifetime injuries to my neck from this accident in which Crystal Sana was the owner of a vehicle that had collided with my vehicle and the unlicensed driver ran away. Judge Mckenna did award me a default Judgment against the father of the child, but the problem is I'm not trained to follow up with the insurance company and collect from my own insurance policy. A Mr. Kim from Gallagher and DeRobertis, I thought would follow up with the case, but he ended up giving me the shaft after a few weeks for reasons unknown to me. I cannot express all of my wrecks in detail with just so little time to gather all of my facts and review all of my previous cases. I am JUSTICE LESS AND REFUSE TO ACCEPT FOR THE FACT THAT JUDGE MCKENNA CLAIMS TO UPHOLD TOTAL JUSTICE IN HONOLULU. THE SYSTEM HERE, IS NO WHERE NEAR A SYSTEM OF THE STATE OF CALIFORNIA, AND WILL NEVER BE IF WE CONTINUE TO MOVE UP THE JUDGES THAT UPHOLD JUSTICE FOR ONLY CERTAIN GROUPS OF PEOPLE. SHE COULD HAVE HELPED ME WITH SOME OF HER COLLEAGUES AND DOESN'T CARE NOR IS SHE EVEN CONCERNED ABOUT MY CONDITION. SHE DOESN'T REALIZE THAT AFTER COMPLETING HER LEGAL ASSIGNMENT BY SPENDING A WEEKEND STUDYING AT THE UH LAW LIBRARY AND TYPING FOR HOURS ON MY WORD DOCUMENT. I am honored to write this letter in support of Judge Sabrina S. McKenna who has been nominated to be an Associate Justice of the Hawaii Supreme Court.

I am sure that you will receive many glowing letters about Judge McKenna relating to her legal skills and judicial demeanor. I have known Judge McKenna for about 20 years. My association with her has been through my work as a private practice attorney in Hawaii.

us attorneys and dealt with our concerns with dispatch and humor. She never treated any concern as trivial, and was unfailingly respectful. I truly do not know how she kept her sanity.

Having received only positive comments from our membership, Hawaii Women Lawyers (HWL) strongly supports the confirmation of the Honorable Judge Sabrina Shizue McKenna as an Associate Justice to the Hawaii Supreme Court. HWL has long recognized Judge McKenna's stature as an exemplary judge and leader in the legal community and, with much acclaim by HWL members, she was the 2006 recipient of HWL's Outstanding Judicial Achievement Award.

As you may know, HWL is a nonprofit business organization made up of female and male attorneys. The purposes of HWL, as set forth in our Articles of Incorporation, are to: (1) improve the status of women in the legal profession; (2) increase the number of women attorneys in positions of authority and responsibility; and (3) promote the advancement of all women. Accordingly, increasing opportunities for, and improving the visibility of, qualified women in the judiciary are important goals for HWL, and we support qualified women candidates in connection with these purposes.

To be clear, HWL's policy is not to endorse just any candidate simply because that candidate is a woman. Instead, HWL's policy is to support *qualified* women judicial candidates. When HWL has the distinctive honor of supporting a qualified candidate who has contributed so much to the Hawaii community that is in line with our goals and our mission, it is especially meaningful to us.

Judge Sabrina McKenna's devotion to improving and widening much needed paths to justice for all people, both on and off the bench, has had a tremendously positive impact throughout the Hawaii community. Although she has served as a judge for nearly 20 years, she has remained a very approachable person, who has lived a full life, rich with a diversity of experiences, always accompanied by her sense of deep compassion and sharing with others, by her gratitude for both her defeats and successes, and by her diligence to achieve excellence in every challenge she faces. As a result, her life has been one of constantly giving back and has been always purposeful in educating and inspiring others about our judicial and legal system.

Insofar as you have reviewed Judge McKenna's impressive and lengthy resume, we will not simply recount her many achievements here. We thought it would be more useful to your consideration of her confirmation if we shared with you the import of the many comments that we received from a number of our members in support of Judge McKenna's confirmation to the Hawaii Supreme Court.

For example, as a fluent speaker of Japanese, Judge McKenna has been one judge who recognizes that linguistic and cultural accessibility are critical issues for our state — particularly in terms of increasing access to our court system. She not only prepared for the panel as if she were writing a bench brief, but also was very well versed in the historical context of language rights and national origin discrimination in Hawaii, as well as federal and state legislation and case law.

That may be something you would expect of any responsible judge addressing the community regarding a social justice issue. However, what was most impressive was her nuanced understanding of the "on-the-ground" issues and challenges experienced by LEP litigants, including what it will actually take for courts to be culturally accessible and competent. In this vein, Judge McKenna has championed the need for qualified, competent and certified interpretation services within the courts as well as the critical translation of vital legal documents. She is remarkably cognizant of the real struggles of marginalized populations and has outlined a clear plan as to how to address the needs of LEP persons on both a practical and ideal level.

Judge McKenna is similarly recognized throughout the community as being honest, ethical and courageous in upholding the law so that it may be accessed and applied equally to all persons. Recently, on January 30, 2011, she was recognized for her courage and achievements as a recipient of the Dr. Martin Luther King, Jr. Friends Award by the Hawai'i Friends of Civil Rights.

My name is Sheryl Nicholson, and I am submitting this testimony in support of Judge Sabrina Shizue McKenna's nomination as an Associate Justice of the Hawai'i Supreme Court.


