My name is Keali'i Lopez, and I am the Director of the Department of Commerce and Consumer Affairs ("DCCA" or the "Department"). The Department appreciates the opportunity to provide testimony on Governor's Message No. 529, regarding the appointment of James Pleiss to the State Board of Chiropractic Examiners ("Board"). The Department supports Dr. Pleiss' appointment and respectfully requests that the Committee recommend that the Senate advise and consent to his appointment to the Board.

Dr. Pleiss has been a licensed chiropractor in the State of Hawaii since 1983 after receiving the Doctor of Chiropractic degree from Northwestern College of Chiropractic in Minnesota. He resumed private practice in November 2000 after spending 4-1/2 years as the staff chiropractor at Maui Occupational Health Center, a multidisciplinary medical facility located in Kahului, Maui. In addition, Dr. Pleiss was appointed to the medical staff of Hale Makua, an extended care facility in Kahululi in October 2000.

Dr. Pleiss is an active member of the Hawaii State Chiropractic Association, having served in numerous leadership positions including Assistant Vice President, Treasurer, Vice President, and President of the Board of Directors, and was awarded the prestigious "Chiropractor of the Year" award in 1994. He is currently serving as the Immediate Past President for the Association.

In addition, Dr. Pleiss is a member of the American Chiropractic Association and the Academy of Chiropractic Orthopedists. He is a board-certified chiropractic orthopedist, one of only 6 to 8 practitioners in the State of Hawaii. Dr. Pleiss also has been serving as an independent chiropractic examiner since 1985.

Dr. Pleiss' community involvement outside of his profession include being a board member of Maui United Way, Chair of Community Service and board member of the Rotary Club of Maui Upcountry, and a Red Cross Volunteer Instructor in the organization's "Protect Your Back" program. He also speaks to numerous hotels, businesses, civic groups, government agencies, and the public on topics ranging from

issues involving the chiropractic profession to back injuries and prevention, safety, and ergonomic assessment.
