TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Keali'i S. Lopez, and I am the Director of Commerce and Consumer Affairs ("DCCA" or the "Department"). The Department appreciates the opportunity to provide testimony on Governor's Message No. 537, regarding the appointment of Rowena Cobb to the Real Estate Commission ("Commission"). The Department supports Ms. Cobb's appointment and respectfully requests that the Committee recommend that the Senate advise and consent to her appointment to the Commission.
