## Response to Questions From The Honorable Carol Fukunaga, Chair, Senate Committee on Economic Development and Technology

(a) Why do you wish to continue serving as a member of the Board of Directors of the High Technology Development Corporation?

I wish to continue on the Board of Directors of HTDC for a number of reasons. First, I have a continuing interest in high technology and the development of high technology. I believe that innovation is critical to the success of a community and that we should support innovation and creativity in technology and business. Second, I have a deep appreciate for the State of Hawaii and see my service on the Board of Directors as a privilege, and also as an opportunity to give back to my community. Third, I believe that my legal and business background can be of value to HDTC and the Board.

(b) As a current board member, how do you perceive the role and responsibilities of a member of the Board of Directors of the High Technology Development Corporation in addressing HTDC funding or operational issues?

As a member of the Board, I see it as my responsibility to facilitate the success of the organization through a wide range of roles, whether it is providing policy guidance, to providing practical leads and developing partnerships with the community in furtherance of HTDC's mission, to providing legal analysis for the benefit of HTDC.

(c) Given your experience in the role and responsibilities of a member of the Board of Directors of the High Technology Development Corporation, why do you believe that you should be reappointed to the board? Please include a brief statement of your skills, expertise, or knowledge that have aided in your decision-making ability as a member of the Board of Directors of the High Technology Development Corporation.

I believe that I can continue to help HTDC in its directive to promote the development and growth of the commercial high technology industry in Hawaii from both a business and legal vantage point. For example, my background has been very valuable to me in reviewing grant applications as a member of the Federal Projects Committee. As a member of this committee, HTDC awarded approximately \$260,000 in State matching grants to fourteen companies that won federal grants and contracts valued at over \$2.7 million in fiscal year 2010.

(d) What do you hope to accomplish during your next term of service?

As you may know, HTDC will need to work out an arrangement to remain in its current facility or will have to relocate to another place. I hope to assist HTDC in securing a location for its operations while continuing to support HTDC mission to provide a wide variety of business development programs and services to support Hawaii's growing technology industry.

(e) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Directors of the High Technology Development Corporation?

I believe that three qualities that make me stand out at HTDC are knowledgeable, direct, practical. My legal and business knowledge, especially in the energy field, provides a valuable point of view in understanding energy related technologies and in being able to see the big picture of developing new technologies. Direct and practical go hand in hand as I am not one to beat around the bush and generally like to get to the point. In reviewing grant proposals, these qualities help sort through the realistic projects from the not so well developed projects, thus giving the organization a better chance of providing successful outcomes to any given grant request.

(f) Name one previous experience that would make you stand out. How has this benefited the Board of Directors of the High Technology Development Corporation during your current term?

My legal background has proven valuable on more than one occasion. In one instance, I assisted in the negotiations and legal documentation of a lease and option to lease agreement for the Maui Research and Technology Center. This guidance probably saved HTDC both time and money with respect to that matter.

(g) Can you foresee any possible conflicts of interests that could arise during your service on the Board of Directors of the High Technology Development Corporation? How would you overcome any possible conflicts of interest?
