Dear Senator Tokuda,

Thank you for your congratulatory letter of March 21, 2011. I am responding to your letter with my written statements to the questions you asked.

I decided to apply to serve on the Hawaii Teacher Standards Board because I believe that all students deserve highly qualified teachers who can provide them with the necessary skills to become productive citizens. I also felt that the opportunity to serve on the Board would provide me with opportunities for professional growth to make me a better teacher.

I feel that I am qualified for this position because I work well with people in general. I possess effective communication skills, am not afraid to disagree, and I base my decisions on evidence rather than assumptions.

I feel that I have always developed strong partnerships with my parents over the twenty years I have taught. Each year, I pay visits to the homes of my students. My students and their parents are provided my cell phone number from the first day of school. They are are allowed to contact me during non-school hours.

I have also developed partnerships between the schools I have taught at and outside organizations. For example, I partnered with the University of Hawai'i's Center for Disability Studies which in turn earned Fern Elementary the connectivity to engage in video teleconferencing and new technology for students (computer, printer, digital and video cameras, and a tripod). My partnership with the University of Hawai'i led to international partnerships with schools in Samoa and Japan through the use of video teleconferencing equipment. When the Department of Education wanted to pilot the AEPL (Asian, European, Pacific Language) foreign language program in the elementary schools, I immediately volunteered in order to provide my students with broader opportunities.

Two years later, every classroom in Fern Elementary was receiving either Japanese or Spanish language instruction that continued for several years. Funding over the years was provided to us from the Department of Education due to the program's success.

My training and experiences while working at the Rehabilitation Hospital of the Pacific prepared me with the skills needed in dealing with a variety of people from departmental staff, administrators, board of directors and irate patients as I managed the accounts receivables for the hospital.

I perceive the role and responsibility of the Hawai'i Teacher Standards Board as one of great importance and that teacher quality and student achievement are in direct correlation. I see every child as my grandchild. I expect the best education for them and to ensure that, it would be our responsibility as Board members to not provide or extend teaching licenses to those whom we feel are not highly qualified to teach in Hawai'i's public school system.

One short-term goal I have is to develop a working relationship with others on the Hawai'i Teacher Standards Board, and the Board of Education. A long-term goal of mine would be to help develop a more positive image of the Hawai'i Teacher Standards Board. I forsee members of the Hawai'i Teachers Standards Board being more visible in the community through outreach activities. Such activities could be volunteering occasionally to clean streams, assist with recycling events in communities, or school improvement projects in our public schools. I feel that this will foster more connectivity with teachers in the field.

I do not forsee any conflicts of interest that could arise during my service on the Hawai'i Teacher Standards Board. If there were any conflicts of interest, I would want to address them. If the issue could not be resolved, then I would willingly resign from my position on the Hawai'i Teacher Standards Board.

I thank you for this opportunity to share my statements with those present today.

The Hawaii State Teachers Association wholeheartedly supports the appointment of **Louise Cayetano** to the Hawaii Teacher Standards Board. Ms. Cayetano has been a teacher in Hawaii since 1988.

She is involved in both educational and community activities. Ms. Cayetano has taught at Lanakila Elementary, Leihoku Elementary, and Fern Elementary schools. Also, through KAUPA (Kalaheo Ahupua'a Ulu Pono Ahahui) that is a non-profit organization created to instill an environmental ethic of caring for the land, she organized and supervised the Kalihi Steam clean-up involving the community and students from a host of schools. For her efforts in this project, Ms. Cayetano

was honored as a Hawaii Thousand Friends Organization 2008 Unsung Heroes and also received a Senate certificate of recognition for her dedication as a volunteer for the Kalihi Stream Clean-ups.

We are confident that her expertise, enthusiasm, dedication to the profession as well as the community will be a great asset to the Hawaii Teacher Standards Board. The board is a very important vehicle by which the public is assured that teachers in the classrooms are qualified to teach. There are standards to which teachers must meet. These standards are set by the board and those who set and monitor standards must themselves be of the highest caliber. Louise Cayetano is in this level of competency.

It is with paramount pleasure that I write this letter in support of LOUISE CAYETANO, for the consideration and confirmation for the Hawaii State Standards Board, Gubernatorial Nominee. Mrs. Cayetano has been an active Hawaii State Department of Education employee for over 25 years. As an educator, she brings a wealth of experience in tending to and sculpting of young minds. Louise spends many hours in her class well after all her students have left, assessing, planning and preparing for the next day, week and month, in moving her students toward achieving proficiency of the Hawaii State Standards.

As a member of Ms. Cayetano's group of pupils, learning does not only take place within the 4 walls of her classroom, her students are taken out into Kalihi Stream and Waianae coast, on her own time, on many, many Saturdays, to become stewards of the land. Throughout the years Mrs. Cayetano has been an advocate of cleaning up polluted waterways, she has taken hundreds of student volunteers to remove debris from our rivers and streams in Honolulu and the Leeward districts. Former students continue to volunteer their Saturday mornings with Mrs. Cayetano making Kalihi stream a healthier habitat. Learning is an active process both in and out of the classroom.

Louise Cayetano is an excellent candidate for this position as she knows Hawaii's struggles and challenges with moving students to meeting academic benchmarks and showing progress as she is at the core of current political focus. She is a classroom teacher at Mayor Joseph J. Fern Elementary School, a public school where 86% of the student population lives in poverty, receiving free/reduced lunch, more than 50% come to school speaking little or no English, ill-prepared to learn and well below their counterparts in other school districts. She has witnessed the change in clientele and the demands made upon teachers - an increase in the amount of work, expectations to bring all students to grade level standards no matter what circumstances the students come with.

You should know that Louise is a loyal and true believer in the public school system; she rolls up her sleeves and digs right in – she makes many attempts to right wrongs, stands firm in her belief that no one is going to pull us out, we need to do the work ourselves. Her students love her, she communicates frequently with parents and bring them up to speed with their child's educational needs and successes, and, participate in all school parent and community meetings.

She is a Hawaii State Teacher's Association representative in every sense as she is in the classroom daily, working with students, parents and staff members for many years. Louise Cayetano makes a well-rounded candidate for this position.
