In consideration of GOVERNOR'S MESSAGE 559 — SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL ISLAND OF OAHU, GUBERNATORIAL NOMINEE CHARLES ANDREW EHRHORN, FOR A TERM TO EXPIRE 6-30-2015

The Department of Land and Natural Resources (Department) supports the gubernatorial appointment of Charles Andrew Ehrhorn to the Island Burial Council, Island of Oahu, for a term to expire 6-30-2015.

The Island Burial Councils were established under Section 6E-43.5, Hawai'i Revised Statutes, to determine the preservation in place or relocation of previously identified native Hawaiian burial sites and to determine Hawaiian cultural and lineal descendent claims for specific burials. State law requires that Island Burial Councils be established for Hawai'i, Maui/Lanai, Molokai, O'ahu and Kaua'i/Ni'ihau islands, and be comprised of representatives from specific geographic regions and representatives of developer/large property owners. Regional representatives are to be selected from the Hawaiian community on the basis of their understanding of the culture, history, burial beliefs, customs and practices of Native Hawaiians. Mr. Ehrhorn will serve as a large property owner (Campbell Estate) representative on the Oahu Island Burial Council.

Mr. Ehrhorn is a graduate of Punahou High School who received his Bachelor of Architecture from the University of Oregon and a Master of Regional Planning from Cornell University. He is a registered architect in Hawaii and has an extensive knowledge and background in (land) planning and urban design. Among his former employers include, Architects Hawaii; Belt Collins & Associates; and the Campbell Estate. Mr. Ehrhorn is currently works as a consultant with C&J Land Planning, LLC.
