SUBJECT: NOMINATION TO THE KAHO`OLAWE ISLAND RESERVE COMMISSION

Thank you for your March 22, 2011 letter regarding my nomination to be the County of Maui's representative on the Kaho olawe Island Reserve Commission (KIRC). Please accept the following responses to your questions:

- (1) I would like to serve on the KIRC to continue the commitment that I made to Kaho'olawe nearly six years ago, when I was first hired by the KIRC. The island, and the people who work toward its restoration, are truly inspiring. When I was asked to join the new administration of Maui Mayor Alan Arakawa, I struggled with the decision to leave the KIRC, so I requested the Mayor's consideration to serve as the County's representative on the KIRC to continue to be involved with such an important and unique mission.
- (2) The easy answer is that the commissioners' duties and responsibilities are established by Chapter 6K, HRS. Beyond these broad statutory duties, though, I perceive the role of commissioners to also be: continuing and expanding the safe and meaningful access to Kaho'olawe for all of Hawai'i's people; providing clear policy direction to the KIRC staff; continuing and improving relationships with stewardship organizations, most notably the Protect Kaho'olawe 'Ohana, and their cultural use of the Reserve; ensuring the KIRC's financial viability; overseeing the appropriate and consistent administration and application of applicable statutes and rules; and, given the remoteness and inherent dangers of Kaho'olawe, protecting the interests of the State of Hawai'i and County of Maui.
- (3) Having worked for the KIRC for more than five years, first as a Policy Advisor and then as Deputy Director, I am thoroughly familiar with KIRC's day-to-day operations on Kaho`olawe and in the Maui office, from administrative, policy, program and field perspectives. I am also thoroughly familiar with the "big picture" issues that the KIRC faces, including the future transition to a Native Hawaiian sovereign entity. With a degree in Political Science and many years of government experience as an analyst and administrator, along with work as a

wildlife rehabilitator and several years learning hula and Hawaiian culture, I believe that I have a broad background in understanding the large spectrum issues that the KIRC has to manage.

- (4) If my nomination is confirmed by the Senate, during my service on the KIRC, I would like to see the KIRC secure a permanent source of revenue from the county, state and/or federal governments (*e.g.*, a share of state conveyance tax revenue as proposed by SB816 and HB1224 this legislative session).
- (5) I believe that I am analytical, fair and a good communicator. These qualities would benefit the KIRC by helping to find the best answers to problems and the best courses of action to take; by considering all perspectives before making decisions; and by facilitating discussion and debate among commissioners and providing direction to staff.
- (6) As previously noted, I worked for the KIRC for more than five years and am intimately familiar with the organization, facilities and assets, staff, programs, projects, budget, governing statutes and administrative rules. This experience would benefit the KIRC because I can "hit the ground running" and bring a practical perspective to the table.
- (7) At this time, I can foresee no potential conflicts of interest with my serving on the KIRC. Should such a potential situation arise, I would disclose the matter to the KIRC and seek the advice of the Department of the Attorney General as well as the County of Maui Department of the Corporation Counsel.
