Hawai'i Civil Rights Commission

The Hawai'i Civil Rights Commission (HCRC) is administratively attached to the Department of Labor and Industrial Relations. The DLIR strongly supports the statutory civil rights enforcement mandate of the HCRC. If confirmed, nominee Linda H. Krieger will make a substantial contribution to the work and success of the HCRC in its important mission.

The criteria for selection to serve as a commissioner on the HCRC, under H.R.S. §368-2(a), includes knowledge and experience in civil rights matters as well as demonstrated commitment to the civil rights of all individuals.

Linda Krieger is a civil rights expert. For over twenty years she worked as a civil rights attorney, first for the Employment Law Center of the Legal Aid Society of San Francisco, then for fifteen years as an attorney with the U.S. Equal Employment Opportunity Commission. She is currently a professor at the University of Hawai'i William S. Richardson School of Law and the Director of the law school's Ulu Lehua Scholars Program. Professor Krieger returned home to Hawai'i in 2007, after teaching at Stanford, Harvard and the University of California at Berkeley. She has taught, written, and spoken extensively on civil rights.

Linda Krieger has worked in civil rights enforcement and in the academy. She has a firm grasp of the law, in practice and theory, and a deep and demonstrated commitment to civil rights. She will be an asset to the HCRC and the state. The DLIR urges favorable consideration of her nomination.
