2. a) Why do you wish to be a member of the State Foundation on Culture and the Arts?

I recently retired from the University of Hawaii system after a 42 year career of teaching visual art and art history at Leeward Community College. I now have the time to try to give back to the community by serving as a commissioner of the State Foundation on Culture and the Arts. As an educator I believe that I can bring my expertise in the arts and arts education in particular to help promote programs of the SFCA, including the Artists-in-the-Schools, Artists-in-Residence at the schools, ArtBento, which brings classes to the Hawaii State Art Museum and the Biennium Grants program, which in many cases go for arts education efforts and other education programs. I am also especially interested in programs that enhance and expand our unique Hawaiian cultural heritage.

2. b) What is your perception of the role and responsibilities of a member of the State Foundation on Culture and the Arts Commission?

The role of a SPCA commissioner is to carry out the mission to promote, preserve, and encourage culture and the arts, history, and the humanities as central to the quality of life of the people of Hawaii. Commissioners must set policy and monitor activities to make sure this mission is fulfilled. In addition, I would like to help better coordinate and market culture and the arts, which in turn would strengthen our visitor industry, and in doing so would enhance our lives here in Hawaii. Making sure that public funds are used responsibly and effectively is also essential. The State Foundation must be creative in forming private/public partnerships to raise money and other support for the programs sponsored by the SFCA. I would like to help seek opportunities for outside funding.

2. c) Why do you believe you are qualified for the position? Including statements of your skills, expertise, or knowledge that would aid in your decision-making ability.

I believe that my six and a half years as the Chairman of the Arts and Humanities Division of Leeward Community College gave me the administrative and organizational skills that I can use in helping to set policy and oversee performance for the HFCA. During my years as Division Chair I supervised 50 faculty and lecturers in disciplines ranging from Art, Music, Dance, Drama, History, Philosophy, Hawaiian Studies, Philippine Studies, Literature and Religion. I was also responsible for scheduling and for the budget. This position helped me develop leadership skills as well as problem solving skills. My long career as an educator and art historian attest to my commitment to the arts and culture. I have served on many articulation committees and worked with System Wide committees to work on ways to help resolve issues and problems within the UH system. As a result I think I could be effective on the SFCA.

2. d) What do you hope to accomplish during your term of service?

I hope to be highly visible and to be in contact with artists, educators, the visitor industry, and to help with the ongoing projects of the SFCA as well as to initiate new projects that can promote art in general, and Native Hawaiian culture and the arts in particular. I would like to be visible to businesses and entrepreneurs and to people who are in a position to help nurture the arts with donations of time or money. I hope to be a spokes person whose commitment is to serve the SFCA in every capacity that will help make it outstanding and supportive of all the arts throughout the State of Hawaii.

2. e) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the State Foundation on Culture and the Arts?

- 1. Passion for the arts
- 2. Passion for education
- 3. Experience teaching and administering education programs.

I sincerely believe in the arts as being essential to every human being. I believe there is no substitution for three-dimensional reality in the arts. In other words, I believe in seeing art first hand. I believe that the arts give us symbols to share and help us all, no matter how diverse our backgrounds, to feel part of a common undertaking. My knowledge of the visual arts, art history, music and the performing arts has been my life involvement and commitment as an educator and communicator.

I like to get along with people and whether in a leadership role or as a team player, I have respect for my colleagues. I worked as a Professional Tour Manager in Europe during the summers for 14 years. I did 12 Study Abroad tours to Europe with

students who came from all 10 campuses of UH as well as HPU and Chaminade exposing them to the Great Museums of Europe. During that time I needed to "stand out" to be highly visible, entertaining as well as encouraging and understanding. I think this might be of benefit and make me an asset to the SFCA.

2. f) Name one previous experience that would make you stand out. How would this benefit the State Foundation on Culture and the Arts?

On December 14, 2010 at my retirement "extravaganza" party I received a Commendation from Governor Abercrombie for my contribution to the arts and for my public service as a Professor of Art. This event took place on the Leeward Theatre stage where 120 of my colleagues and friends throughout the University of Hawaii System and community gathered for an evening of food and entertainment. To honor me some of my colleagues performed by way of their kind words and others by way of their musical, dance and theatrical talent ranging from singing and piano playing, classical guitar, opera, Hawaiian music, pop, and ending with flamenco dancing. This was an experience that truly made me stand out. I later found out that a committee had been working on staging the event for three months. This experience was the culmination of my professional career as an educator but at the same time it also made me want to continue to stand out and to stand up and be involved in the culture and arts. I believe that my experience and knowledge and energy can now be directed to serving as a commissioner on the SFCA.
