The position and views expressed in this testimony do not represent nor reflect the position and views of the Department of Health.

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 612** to confirm the nomination of Joe D. Cordova for a term to expire June 30, 2015.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following agencies are required to be on the Council: Department of Health; the agencies that administer funds provided under the Rehabilitation Act of 1973; the Individuals with Disabilities Education Act; the Older Americans Act of 1965; Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; agencies and private non-profit organizations concerned with services to individuals with DD. The Governor's nominee meets all the Federal requirements for Council membership.

Mr. Cordova was first appointed to the Council in 2007. His reappointment would fulfill the Federal requirement of having a representative from the agency that administers funds provided under the Rehabilitation Act of 1973. He has a wealth of work experience in the disability field that includes computer program analyst; mental health counselor; special advisor to the Mayor of the City of Albuquerque, New Mexico; Deputy Director for the New Mexico Commission for the Blind; Director for the Division for the Blind and Visually Impaired, Rehabilitation Services Administration (RSA), U.S.

Department of Education (DOE); Regional Commissioner, Regions V and VII, Kansas City and Chicago Regional Offices, RSA, DOE; and Administrator for the Division of Vocational Rehabilitation (DVR) and Services for the Blind, Department of Human Services.

His numerous experiences and current position as Administrator of DVR will assist the Council in its activities to increase post-secondary education and employment options, and supports for people with DD to obtain and sustain employment of their choice. His participation on the Council's Employment and Education Committee would enable the Council to move forward with activities to promote efforts by State agencies and Counties to utilize federally-legislated work programs and obtain grants for developing micro-enterprises, self-employment, and small businesses.
