SUBJECT: GM 615 – State Council on Developmental Disabilities Gubernatorial Nominee Roselani M. Rowe

The position and views expressed in this testimony do not represent nor reflect the position and views of the Department of Health.

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 615** to confirm the nomination of Roselani M. Rowe for a term to expire June 30, 2015.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the players involved in the development, implementation, and use of DD supports are represented. The law specifically requires that 60 percent of the membership of the Council be comprised of individuals with DD, their parents, or family members. Additionally, the following agencies are required to be on the Council: Department of Health; the agencies that administer funds provided under the Rehabilitation Act of 1973; the Individuals with Disabilities Education Act; the Older Americans Act of 1965; Titles V and XIX of the Social Security Act; the Protection and Advocacy Agency; the Centers for Excellence in DD Education, Research, and Service; agencies and private non-profit organizations concerned with services to individuals with DD. The Governor's nominee meets all the Federal requirements for Council membership.

Ms. Rowe is a sister of a family member with DD. She was first appointed to the Council in 2007. Her reappointment to the Council would fulfill the Federal requirement of a family member of an individual with DD. She served as Council Chair from July 2008-June 2010, and is a current member of the Council's Employment and Education Committee that addresses employment of individuals with DD and transition of individuals from high school to post-secondary education and employment.

Ms. Rowe's senior management, administrative assistant, and classroom experience working at the Special Education Center of Hawaii, Project Coordinator for the Po'ohala Family Support Project, and Parent Counselor at the Learning Disabilities Association of Hawaii would provide the Council with the "voice of families" in planning and carrying out activities to support families of individuals with DD. As a family member, she would assist the Council in advocating for individuals with DD to have choice of residential setting, employment, recreation and leisure, and for services to be individualized and consumer-directed.


