It is with pleasure that I write in support of the nomination of Marilyn Seely to the Policy Advisory Board for Elderly Affairs.

Ms. Seely is uniquely qualified to be a member of this advisory board. As a well educated and deeply experienced specialist in gerontology and public health, she has firsthand knowledge of the needs of our aging population. She is adept at developing and running programs to ensure that our senior years are as full and healthy as possible, while working diligently to see that policies and practices are in place so that the elderly need not fear their final years. In this regard, there is still much work to be done and I believe Marilyn can make a great contribution to building a better system of aging services for Hawaii.

Marilyn, first as staff, and later as Executive Director of the Executive Office on Aging, had responsibility for state wide programs addressing the needs of Hawaii's seniors. In her capacity as director, she was well known and widely respected as a staunch and successful advocate for the elderly.

Along with the Advisory Board, she developed numerous policies to address the physical, social and health care needs of the aging, particularly those in the low income sector. Unfortunately, while this bill was passed by the 2003 legislature, it was not enacted into law. Very importantly, Marilyn was responsible for ensuring the welfare of the aging residing in long term care facilities and was vigilant about maintaining the high standards of the Long Term Care Ombudsman to provide oversight.

While there is much more that could be said in support of Marilyn Seely's nomination, I think the foregoing will give you a flavor of her ability to serve this state well as a member of PABEA. I recommend her to you without reservation.
