

Chairman Green, Vice Chair Nishihara, and members of the committee, thank you for giving me the opportunity to appear before you today.

I am honored and humbled to be considered to serve as the Administrator for Hawaii's State Health Planning and Development Agency. I'd like to thank Governor Abercrombie for nominating me and for giving me this opportunity to be considered by the Senate.

I came to Hawaii with my parents 36 years ago, in 1976, and as soon as we arrived we knew Hawaii was our home.
