### Why did you decide to apply to serve on the BOE?

As mentioned above, my 12 years of working closely with the public high schools while serving as HHSAA Executive Director helped me gain a good grasp of the inner workings of the DOE (and BOE). As for three qualities that make me a qualified candidate: (1) Many years of working with the DOE and BOE; (2) My attorney background, including several years in private practice as a litigation attorney; and (3) Born and raised in Hawai'i, with a deep concern for our youth.

<u>Please identify one short- and one long-term goal you would have as a BOE member</u> and how you would accomplish these during your term of service.

Short-term goal: Examine the DOE's policies and procedures and make any necessary changes so that the BOE is more policy-oriented and the Superintendent is fully in charge of day-to-day operations and given the necessary tools to succeed in accomplishing the DOE's goals.

Long-term goal: Hawai'i's public school students are at the top of the nation in terms of achievement, including test scores, graduation rate, and college readiness.

Can you foresee any possible conflicts of interest that could arise during your service on the Board of Education? How would you overcome any possible conflicts of interest?

Initially, I was concerned that serving on the BOE would conflict with my current position as Executive Administrator and Secretary of the University of Hawai'i's Board of Regents. However, Governor Abercrombie's staff has researched this issue and has found that I would be able to serve in both capacities if confirmed for the BOE position.

However, if any conflict of interest should arise, I would certainly recuse myself from being involved in the conflict of interest issue.
