Dear Senator Tokuda:

I submit the following for your consideration of my nomination as a member of the Board of Education.

# (1) Why did you decide to apply to serve on the BOE?

Having served as the first student representative to the Board of Education, I have always taken a strong interest in government and particularly the governance of our schools. The year of service on the Board was somewhat tumultuous being that it was the year of the HSTA strike. The experience had a tremendous impact on my career path and fueled my drive to further my education and serve my community. My youngest daughter was born with down syndrome. It has been a challenge for our family. Our involvement with the Department of Education has been a valuable learning experience. We have devoted many hours away from work towards our daughter to improve her life and give her the promise of a positive future after we as her parents are no longer able to provide care. It is a sobering thought but through the Individualized Education Program it has given us hope as we witness progress. I would never have sought election to the Board of Education because I did not desire to become reinvolved in elective politics as a candidate. However, when the Board became an appointed board, I strongly believe that it was a calling to apply and serve my community in this capacity. Based on my lifelong experience, having worked at the legislature as the clerk for the House Committee on Education for former Superintendent Charles Toguchi, who was then the Chair, my higher education in political science, public administration, and law, and my many years of experience working with families as a family law attorney, I know that I will be able to contribute in a positive and constructive way.

(2) In light of recent changes to the Board's composition, how do you perceive the role and responsibilities of individual members and the overall role of the BOE in regards to educational decision-making?

Although the Board is comprised of individual members. the BOE may only take action as a Board. The Board is not responsible for day to day operations but rather sets policy directives that are enacted by the Superintendent of Education and State Librarian. Individual board members should be fully prepared to participate and we should as individual members ensure that each member may effectively participate. The Board should ensure that the public has access and input in the decisions that affect the quality of our schools and libraries and the public should be encouraged to participate. Each Board member should ensure that the Board complies with all laws applicable to the Board, Department of Education and State Public Library System. Board members should also avoid being placed in a conflict of interest position.

(3) Given your understanding of the role and responsibilities of a member of the BOE, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, experience, or knowledge that would aid in your decision-making ability as a member of the BOE.

I believe that I have been trained my whole life to undertake this awesome responsibility in these challenging and difficult time. Resources are limited, priorities are being questioned, our citizens find it very difficult to meet their obligations. Our public schools provide hope for a positive future not only for the students that attend but for the families that dream of a better life for their children. I was blessed with always having supportive teachers and administrators that provided positive life lessons that I reflect on to this day and which I try to pass down to those who ask for my advice. The following will aid in my decision-making ability as a member of the BOE: 1. My training and work experience as staff person at the legislature. 2. My experience as a council member in evaluating programs and budgets for various departments. 3. My recent experience with the merit appeals board, and with my former role as a member and Chairman of the Hawaii County Council for six years provide some insight on the workings of our collective bargaining law. 4. Being involved in our community, and working with people from a myriad of backgrounds, provide me with the skills to engage in public discussion about the policies that the Board must review and enact. 5. My background in public administration provides insight that policies need to be clear, capable of implementation and evaluation, and the need to consider and understand the fiscal implications of the policy. 6. Finally, my training as a trial lawyer hopefully will assist to articulate, persuade, and explain the intricacies of policy so that it is logical, understandable, and acceptable to the community as a whole.

# Three Qualities:

Problem solver: I tend to focus on identifying problems and finding solutions rather than laying blame.

Positive thinking: Strive to accentuate the positive and not dwell on the negative.

Flexibility: Willing to change my plans or ideas without getting upset.

(4) Please identify one short- and one long-term goal you would have as a BOE member and how you would accomplish these during your term of service.

Short term goal is to immediately focus energy and efforts from servicing the BOE to providing assistance and resources to the schools to improve student performance. School administrators and teachers know what students require to improve their performance. They know the names of the students and usually are aware of each students individual problems that may be contributing to their failure to perform as expected. I would also want to visit the schools of the Island I represent as well as all of the public libraries to demonstrate a commitment to be open and accessible.

Long term goal is to communicate to each community the positive accomplishments of our schools and specifically of our students and to commend the efforts of administrators, teachers, parents, and students in accomplishing the goals that were set by the Race to the Top grant.

(5) Can you forsee any possible conflicts of interests that could arise during your service on the Board of Education? How would you overcome any possible conflicts of interest?

I have undertaken representation of students and parents in the past in disputes with the Department of Education. I shall **not** undertake such representation in the future. I am a parent of a special needs student. The Board of Education is not involved in day to day operations and I would never seek any accommodation for my child that was not available for any student similarly situated.

# TESTIMONY ON GM 654 RELATING TO BRIAN J. DE LIMA FOR THE POSITION OF HAWAII ISLAND MEMBER HAWAII BOARD OF EDUCATION

Chair Tokuda, Vice Chair Kidani, and members of the committee, thank you for giving me this opportunity to appear before you today.

It is a privilege and honor to be considered to serve on the Hawaii Board of Education and I want to publicly thank Governor Abercrombie for nominating me and giving me the opportunity to be considered by the Senate.

I am a product of our public schools. I am proud of the education I received and thankful to the many teachers, staff, principals, and administrators that participated in my education. There are many people who have also supported me in my childhood from the neighbors growing up on Kinoole and Mamo street in Hilo, the kids, coaches and staff at the Boys Club of Hilo, the youth advisors at the YMCA and its Youth Legislature program and of course, my parents, uncles/aunts, cousins, and friends. I truly experienced a community raising a child.

I have always had a strong interest on matters that affect my life and the community in which I live, work, and play. While a student at Hilo High School, I was the senior class president and was elected to be the President of the Big Island Association of Student Councils. I also served as the representative to the State Student Council, and I was then elected

to be the first student representative to the Board of Education in 1972. The experience had a tremendous impact on my career path and fueled my drive to further my education and serve my community.

I first attended the University of Hawaii at Hilo, where I served as Student Body President in 1974-75, and the highlight was a week long symposium on the "Use and Misuse of Our Land, Energy, and Natural Resources", in which scholars, nationally renowned speakers, local leaders, and students discussed problems and solutions. I transferred the following year to the University of Massachusetts at Amherst. I was a student leader at the University of Massachusetts and was involved in numerous activities.

In 1979, I returned home to Hawaii and worked as a staff person at the legislature during the 1980 through 1983 legislative sessions. In 1982, I served as the House Education Committee Clerk. I enjoyed the experience of working with Representative Charles Toguchi on early childhood education programs and legislation to provide school priority funds. I had a sense that we were making a difference.

I graduated from the William S. Richardson School of Law in 1983 and returned home to Hilo, I opened my own law office and have been in partnership of Crudele & De Lima since 1996. I have been a trial attorney working on a myriad of cases over the years. However, a majority of my practice has always been family law. Working with the complex issues that families experience every day.

In my own life, I have experienced many challenges, however, my most noteworthy accomplishment is that I believe I have a happy family. My wife Paige attended public school in Kona until she started attending Hawaii Preparatory Academy (HPA) where she graduated. In our home, my eldest daughter Blaise also attended public school in Hilo until she also attended her Mother's alma mater and graduated from HPA. There were many benefits in Blaise's schooling at HPA. She was required to participate in varsity athletics required to attend school on Saturdays,

attend mandatory study hall, and perform mandatory school service. She enjoyed her experience. This experience provides me an additional frame of reference.

I recognize that my experience with my younger daughter who is a special needs student who is still attending public school in an inclusion setting is a different experience from what most parents experience. Parents of special needs students have different challenges with the Department of Education. Parents have to deal with their own struggles of every day life, it is not easy, many times it is overwhelming and many times we need assistance. The Department of Education and the individuals with whom we need to interface with sometimes are creatures of regulation and procedure. Parents who are struggling to deal with the needs of their child try to be strong advocates for their children and many times are incapable of expressing what is needed. Many parents tend to accept and trust what is proposed and given. I know that the system is full of caring and loving people who are dealing with limited resources. Through such difficulties, I have seen the love and sincerity that these professional educators possess as they do their jobs. Many times doing small miracles with very little but a desire to do good. The struggle comes when people have problems and that is when patience and understanding is paramount. Many of these parents are dealing with doctors, speech therapist, occupational therapist, physical therapist, behaviorist, educational assistants, administrators and teachers. It is overwhelming but necessary. I hope that my participation with the BOE will assist in ensuring a degree of empathy as we deal with allocation of resources and enactment of policies.

I applied to be a member of the Board of Education because I know that we are at a crossroads. Many people talk about the challenges of our budgets, unions, laws and regulations. However, I know the educators chose this profession because of the passion to make a difference. I know that students that achieve, work hard not only inside but outside of the classroom. I know that parents, coaches, neighbors, friends, and everyone

that interacts with young people, all make a difference in achieving success and progress. Our public schools produce year in and year out, great citizens, scholars and leaders, many of our legislators are products of our public schools. Our schools are good. We need to help those students that are struggling that need motivation. Success requires a collaborative effort if at all possible. However, sometimes there is no parent to motivate and it takes someone else to help, sometimes it may take students helping students. Whatever it takes!

I know that our students and communities are up to the challenge. The Race to Top grant was a competition. Hawaii residents have always met challenges and we stick together when challenged. Student achievement scores in math and reading require improvement, this is a challenge. I will start in trusting our people and residents. I will trust the teachers to teach and I will trust the Superintendent to provide the leadership and to empower the teachers to motivate and to provide the students the skills to succeed. I will work collaboratively with the other members of the Board to do what we must at this critical time.

In closing, for those that submitted testimony, I want to express my appreciation to everyone who took the time to participate in this process. I thank Senator Tokuda for the questionnaire to allow us to provide information for the committee. I also appreciate the courtesies and assistance the staff have provided. I also want to thank the committee for giving me the opportunity to appear before you and for considering my nomination and I will try my best to answer any of your questions.

Without going into the depths of socio-psychological study and explanation, if the BOE member <u>does</u> like himself, he or she will be able to like other people, be understanding of difference, be willing to make mistakes, and will look for positives in people and situations.

The foregoing characterizes Mr. Brian De Lima: He <u>is</u> self-confident! With self-confidence, Mr. De Lima can accept his own weaknesses and limitations and contribute more readily towards the BOE's mission.

## 5. A Warm Personality

In working together for a common goal, BOE members should generate warmth in matters of speech and/or behavior. It may be an open, exuberant warmth or quiet gentle warmth. Mr. De Lima characterized both-mentioned positive personalities.

## 6. Humor

In order to consummate vital educational pursuits within deadline aplenty, a BOE member, at times, needs to be relaxed and able to laugh with the others. At times, he needs to laugh at himself, which Mr. De Lima is very able to do.

## 7. Maturity

BOE members should be mature in their commitment to education and be able to cope with wins losses, disappointments, and isolation as well as the excitement of being a respected board member who is looked up to by the citizentry-at-large. Mr. De Lima is noted to be possessed of these qualities.

## 8. Teachers & Their Role

When I read that Brian De Lima was submitted by Governor Abercrombie as a Nominee to the BOE my first reaction was: Neil has started his own Draft? I mean, who could possibly volunteer for this? The public expectations are so high and the available funds are so low to meet those expectations that the combination is an invitation to a disaster waiting for a place to happen.

When my colleagues in the prosecutor's office learned that I intended to submit testimony supporting Brian, a few responded, "Oh Rick, sneaky, if he is at BOE meetings, Brian won't have time to beat us up in court," and, "When did you become a Democrat?" I plead not guilty on both counts.
